In the matter of: CWP No. 10462/2024-titled as Suresh Kumar, Vs. State of H.P. & Others.

Whereas, Sh. Suresh Kumar, TGT (NM) preferred CWP No. 10462/2024 titled as Suresh Kumar, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Mool Bhaji, U/C GSSS Thaila, Distt. Shimla, H.P to nearby station at his native place in Distt. Hamirpur, and Distt. Bilaspur, H.P . The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 15-10-2024 when the Hon'ble High Court has passed the following orders:-

*"1. Learned counsel for the petitioner submits that w.r.t. the grievances being raised in the present petition, representation dated 17-07-2024(Annexure P-5) stands made to the concerned authorities. Petitioner is free to pursue the representation so made.*

*"2. In view thereof, present petition is disposed of, so also the pending application(s), if any.*

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 06-12-2024. He attended the same and submitted his representation in this office on 06-12-2024, vide which he has requested that he may be transfer from GMS Mool Bhaji, U/C GSSS Thaila, Distt. Shimla, H.P. to nearby station at his native place in Distt. Hamirpur, H.P, against vacancy and GSSS Barota, Distt. Bilaspur, against vacancy being caused due to retirement of present incumbent on 31-12-2024. At present there is no vacancy of TGT(NM) in District Hamirpur and Distt. Bilaspur, H.P.

From perusal of record, it has been found that the petitioner has been working at GMS Mool Bhaji, U/C GSSS Thaila, Distt. Shimla, H.P. w.e.f 06-10-2017 and has completed his normal tenure at present place of posting. At present (13) students are studying in GMS Mool Bhaji, Distt. Shimla, H.P and only one TGT(NM) is working there. As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in para 12.1 "All employees during their period of service will serve for at least single tenure in the Tribal/Hard area and remote/rural areas. Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the State, Keeping in view of the administrative exigencies/ convenience". Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
