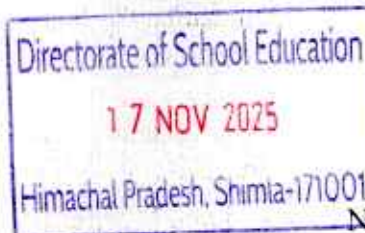
In the matter of:- CWP No. 15552/2025-titled as Hardeep Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court vide which sought his transfer at one of the station of his choice. The present CWP was listed before the Hon'ble High Court of H.P. on 25.09.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 14-11-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Hardeep Kumar, TGT (Arts), submitted fresh representation and stated that he has completed his normal tenure at GSSS Seri Batwara Distt. Mandi i.e hard area of Distt. Mandi and his wife is a hurt patient & there is nobody who can properly take care of her so that requested for adjustment at GSSS Dhaner Patrighat Distt. Mandi or GMS Bhaderwani, GHS Sulpur Bahi Distt. Mandi, GMS Dimmi u/c GSSS Tikker Khatriyan Distt. Hamirpur, GSSS Bagragalu Distt Mandi.

From the perusal of the record, it is found that Sh. Hardeep Kumar, TGT (Arts), is posted at GSSS Seri Batwara Distt. Mandi, w.e.f. 09.08.2021 and he has completed his normal tenure in the hard area of District Mandi. One post of TGT (Arts) is lying vacant at GSSS Dhaner Patrighat Distt. Mandi, wherein about 77 students are enrolled, which also falls within the choice station of the petitioner.

Keeping in view the position stated above, representation of the petitioner is considered sympathetically and Sh. Hardeep Kumar, TGT (Arts), posted at GSSS Seri Batwara Distt. Mandi is hereby transferred to GSSS Dhaner Patrighat Distt. Mandi against vacancy, without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of.
