ORDER

In the matter of:

CWP No. 13014/2024-titled as Ramna Devi (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Smt. Ramna Devi, TGT (Med.) has filed CWP No. 13014/2024 titled as Ramna Devi V/s State of H.P. in the Hon'ble High Court, and seeking her transfer from GSSS, Pajja Distt. Chamba either to GSSS, Forsythganj Distt. Kangra, PM Shri GGSSS Dharamshala Distt. Kangra, GSSS, Mandal Distt. Kangra, GHS Sidhwari Distt. Kangra. The case was listed before the Hon'ble High Court of H.P. on 26.11.2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"In view of the above, this writ petition is disposed of with a direction to respondent No.2 to consider and decide the aforesaid representation of the petitioner dated 15.05.2024 (Annexure P-10 Colly.) for her transfer from GSSS Pajja, Distt. Chamba in accordance with law and applicable transfer policy, within a period of two weeks from today. The decision so arrived at shall also be communicated to the petitioner.

The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(S). if any.

The petitioner i.e Smt. Ramna Devi, TGT (Med.) was called for personal hearing and appeared before the undersigned on 06.12.2024. At the time of hearing she has submitted fresh representation vide which she stated that the child of the petitioner is studying in the native place of the petitioner in Distt. Kangra and are residing with the parent in laws and it is very difficult to take care of the children as she is posted far away approximately 180 KM from her native place. It is also relevant to mentioned here that the father-in-law of the petitioner is very old and suffering from old age ailments and there is nobody to take care of him except the petitioner. She has requested for her transfer to GSSS, Forsythganj Distt. Kangra, PM Shri GGSSS, Dharamshala Distt. Kangra, GSSS, Mandal Distt. Kangra, GSSS, Matour Distt. Kangra, GHS, Sidhwari Distt. Kangra vice longer stayee by clubbing their previous stay, in view of her family circumstances.

From the perusal of record, it is found that Smt. Ramna Devi, TGT (Med.) is working at GSSS, Pajja District Chamba since 03.03.2019 and has completed normal tenure at her present place of posting. However, one Sh. Rajinder Singh, TGT (Med) is working in GSSS, Forsythganj Distt. Kangra since 04.09.2023 and having short stay, but serving within the radius of 30 Km. (Aprx.) since 2014. The continuous services rendered by employees of Education Department within a radius of 30 Km. be considered stay/tenure at one station & such services will be clubbed for calculation of tenure purpose of transfers.

Keeping in view the position stated above, representation of petitioner is considered sympathetically and she is hereby transferred from GSSS, Pajja District Chamba to GSSS, Forsythganj District Kangra vice Sh. Rajinder Singh, TGT (Med.) and vice versa by clubbing his previous tenure (with TTA/JT) to Sh. Rajinder Singh. Keeping in view the position stated above, representation of the petitioner i.e Smt. Ramna Devi, TGT (Med.) is disposed of accordingly.


