Whereas, Sapna Devi, TGT (NM) preferred CWP No.8859/2025 titled as Sapna Devi Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Sandhu, Distt. Shimla, H.P to nearby her native place in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 28-05-2025 when the Hon'ble High Court has passed the following orders:-

3"Having taken note of the fact that petitioner has already completed normal tenure of posting at present station, coupled with the fact that minimum tenure of posting at one station is three years, this Court without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide her pending representation (Annexure P-1) expeditiously, preferably, within a period of four weeks from today. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of vacancy at Government High School, Rori Kori, Tehsil Dadasiba, District Kangra, which is likely to fall vacant on 01.07.2025. Pending application(s), if any, shall also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 19-06-2025. She attended the same and submitted her representation in this office on 19-06-2025, vide which She has requested that She may be transfer from GSSS Sandhu, Distt. Shimla to nearby his native place in Distt. Kangra, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms. .

From perusal of record, it has been found that the petitioner has been working at GSSS Sandhu, Distt. Shimla, H.P since 18-11-2019 and has completed her normal tenure at present place of posting. One post of TGT(NM) is going to be vacant due to retirement of present incumbent at GHS Rori Kori, Distt. Kangra, H.P. on 30-06-2025. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and She is hereby transferred without TTA/JT from GSSS Sandhu, Distt. Shimla, H.P. to GHS Rori-Kori, Distt. Kangra, H.P. against vacancy likely to be caused due to retirement of present incumbent 30.06.2025. These orders will be implemented after the retirement of present incumbent on 30.06.2025. The representation of the petitioner is disposed of accordingly.
