The petitioner has filed present CWP No. 9387/2025 titled as Jitender Kumar, TGT (Arts) V/s State of H.P. in the Hon'ble High Court against his transfer order dated 02.06.2025 from GSSS Dasehra Distt. Mandi to GSSS Panjalag Distt. Mandi and sought his adjustment. The case was listed before the Hon'ble High Court of H.P. on 09.07.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"....having taken note of the fact that son of the petitioner has been recently operated, as is evident from the medical document adduced on record, this Court deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation to the competent authority within a period of two days, praying therein for his adjustment at a convenient station, enabling him to take care of his ailing son, which in turn, shall be decided by the competent authority expeditiously, preferably within a period of ten days, taking note of transfer policy, formulated by the Government of Himachal Pradesh, which certainly enables an employee to seek transfer/ adjustment at a convenient station on account of adverse family circumstances. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order. Till the time representation, if any, filed within a period of two days is not decided by the competent authority, petitioner shall not be compelled to join at the transferred station."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on dated 26.07.2025 and appeared before the undersigned on the scheduled date. The petitioner has requested a transfer or adjustment to either GSSS Rajwari, GMS Nalni under GSSS Maloh, or GMS Gutkar u/c GSSS Bagla in District Mandi due to adverse family circumstances. His son has recently undergone surgery and is currently receiving medical treatment.

From the perusal of record, it is found that Sh. Jitender Kumar, TGT (Arts) has been posted at GSSS Dasehra Distt. Mandi and his transfer order was issued to GSSS Panjalag Distt. Mandi on dated 02.06.2025. At present post of TGT (Arts) are not lying vacant in the petitioner preferred schools, but one Sh. Brahm Dass, TGT (Arts) is working at GSSS Rajwari Distt Mandi since 23.08.2022 and serving within the radius of 30 Krns.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically. Accordingly, Sh. Jitender Kumar, TGT (Arts), posted at GSSS Dasehra Distt. Mandi and u/t to GSSS Panjalag Distt. Mandi is hereby adjusted at GSSS Rajwari Distt Mandi, vice Sh. Brahm Dass, TGT(Arts) and vice versa basis by clubbing his previous place of postings tenure (with TTA/JT to Sh. Brahm Dass, TGT(Arts). The representation of the petitioner in the present CWP s ands disposed of accordingly.

Whereas, Sh. Gian Chand, TGT (NM) previously working in GSSS Behal, Distt. Bilaspur has filed CWP No. 11975/2025 titled as Gian Chand, TGT (NM) Vs. State of H.P & others. before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Solan/Bilaspur. The case of the petitioner was listed before the Hon'ble High Court on 25.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"2. Vide order dated 22.05.2025 passed in CWP No.8517 of 2025, this Court had specifically called upon authority concerned to consider the representation of the petitioner for cancellation of his transfer order on the ground of couple case, however, authority concerned nowhere dealt with the aforesaid point and as such, impugned order dated 08.07.2025 (Annexure P-4) deserves to be quashed and set-aside. Ordered accordingly. Director, School Education, Himachal Pradesh, is directed to decide the representation of the petitioner afresh, strictly in terms of observations made by this Court while passing order dated 22.05.2025 passed in CWP No.8517 of 2025 as well as Transfer Policy, formulated by the Government of Himachal Pradesh, which certainly enables an employee to seek transfer on the ground of couple case. Needful in terms of instant order shall be done expeditiously, preferably, within a period of ten days. Till then, petitioner shall not be compelled to join the transferred station, however, he may avail leave of kind due, if any. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 30.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GSSS Jharmajri or GSSS Jabbal Jamrot or GSSS Baha or GSSS Bhatian or GMS Ratyore u/c GSSS Dabhota or GSSS Manpura, Distt. Solan/Bilaspur against longer stayee or against vacancy

After perusal of the relevant record, it is revealed that the petitioner was transferred GSSS Behal, Distt. Bilaspur to GMS Ramni, Distt. Kinnaur vide order dated 14.05.2025 with the prior approval of competent authority.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted at GSSS Jabbal Jamrot, Distt. Solan against vacancy without TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.

The case was listed before the Hon'ble High Court of H.P. on 23.06.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-
