

ORDER



Whereas, petitioner namely Parmod Kumar TGT(NM) GMS Langehar u/c Baroti (MND) Distt. Mandi having TGT seniority number 18636 have claimed promotion to the post of Lecturer(School-New) in Commerce subject and filed CWP No. 2543/2023 before Hon'ble High Court and Hon'ble High Court has directed as under:-

The petition is disposed of with the direction that in the peculiar facts of this case, the exemption that is contained in Notification dated 14.05.2012, Annexure P-2, with regard to percentage of marks and possession of the educational qualification etc. shall be extended to the petitioner also while considering his candidature for promotion to the next post by deeming the petitioner as having joined before 19.08.2011, for this purpose. The respondents are directed to hold a review DPC within four weeks from today and consider the petitioner for promotion against the post of Lecturer (New School), and if he found eligible, he be also offered promotion from the date when other candidates, who were initially recruited alongwith the petitioner, were promoted against the said post. In case, the petitioner is found eligible for promotion, then benefits that are accruable thereupon shall be notational as from the due date till the date of filing of the writ petition and thereafter, actual benefits shall accrue. The petition stands disposed of in above terms. Pending miscellaneous application(s), if any also stand disposed of accordingly.

Whereas, the case of the petitioner is that he was appointed as TGT (Non-Medical) vide Notification dated 11.08.2011. In terms thereof, the petitioner was ordered to be posted at Govt. Sen. Sec School, Thunag. In compliance to the said notification, he went on 16.08.2011 to GSSS, Thunag, to submit his joining, but his joining was not accepted on the ground that the post of the TGT (Non-Medical) was not vacant. Pursuant to this, the order of appointment of the petitioner dated 11.8.2011, was modified vide office order dated 20.08.2011 and he was ordered to be now posted at Govt. High School, Tihri, District Mandi, HP. In compliance to the order dated 20.08.2011, the petitioner joined at the new place of his posting w.e.f. 23.08.2011.

And whereas as per the notification dated 14.05.2012, the Himachal Pradesh, Higher Education Department, Post Graduate Teacher, Class-III, (Non-Gazetted) Recruitment and Promotion Rules, 2010, the amendment so carried out in Colum No. 10 thereof, had a provision that the minimum percentage of marks in Master's Degree in the subject concerned and in Bachelor of Education Degree (B.Ed) as professional qualification, would not be applicable to those who were working/engaged with the Department as Trained Graduate Teachers (TGTs) prior to 19.08.2011 for the purpose of assessing eligibility for promotion to the next post i.e. Lecturer (School New). This benefit stands denied to the petitioner.

Now therefore, in view of Hon'ble High Court orders dated 08.04.2024 petitioner namely Sh. Parmod Kumar having TGT sty number 18636 is hereby promoted as Lecturer (School-New) in commerce subject w.e.f. 30.08.2022 notionally and actual financial benefit will flow from the date of filing writ i.e 04.05.2023. Further on promotion he is posted in GSSS Sai Distt. Solan against vacancy. He is directed to join on promotional post with in five days.

May inform the parties accordingly.


