## **ORDER**

In the matter of:-

CWP No. 13878/2025-titled as Vijay Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court vide which sought his transfer from GSSS Loharghat Distt. Solan to one of the station of his choice. The present CWP was listed before the Hon'ble High Court of H.P. on 28.8.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 10-09-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Vijay Kumar, TGT (Arts), submitted fresh representation and requested that he is working at GSSS Loharghat (Solan) since May, 2025 and facing adverse family circumstances, as his parents are old age and suffering from various old age ailments and no one in the family of the petitioner to look after them, therefore, petitioner has sought his transfer either to GMS Kalari u/c GSSS(B) Gamarwin Distt. Bilaspur, GSSS Salaon, GSSS Talyana Distt. Bilaspur.

From the perusal of record, it is found that Sh. Vijay Kumar, TGT (Arts), is working at GSSS Loharghat Distt. Solan since 09.05.2025 & as such not completed his normal stay, further the institution i.e. GSSS Loharghat is classified as a soft area within District Solan wherein 130 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right."

Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected on the grounds that the petitioner having short stay further he is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GSSS Loharghat Distt. Solan. It is further considered that the transfer of the petitioner at this stage would adversely affect the studies of the students during the mid-academic session. Hence, in view of the aforesaid facts and circumstances, the representation of the petitioner is rejected and stands disposed of. All the concerned are intimated accordingly.
