## **ORDER**

In the matter of:-

CWP No. 11751/2025-titled as Naresh Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court vide which sought his transfer from GHS Kalhani u/c GSSS Sarachi Distt Mandi to one of the station as detailed in the representation, enabling him to take his son for treatment to PGI Chandigarh on regular basis. The present CWP No. 10441/2025 was listed before the Hon'ble High Court of H.P. on 22.07.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Though having carefully perused averments contained in the petition, which are duly supported by an affidavit, this Court finds that petitioner has not completed normal tenure at present place of posting, but since Transfer Policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer/adjustment on medical grounds, coupled with the fact that son of the petitioner is unwell and for that purpose, he is regularly taken to PGI Chandigarh, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation (Annexure P-3) of the petitioner expeditiously, preferably within three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for personal hearing on 14.08.2025 and appeard before the undersigned on scheduled date. The petitioner has stated that his son is unwell and for the purpose, he regularly taken to PGI Chandigarh and sought his transfer either to GHS Baroha, GMS Tanyur u/c GSSS Dhanather, GSSS Rishikesh, GHS Dokru u/c GSSS Jhandutta, GSSS Salwar, GHS Gangloh u/c GSSS Jaddu Kulziar Distt Bilaspur.

From the perusal of record, it is found that Sh. Naresh Kumar, TGT (Arts) is working at GHS Kalhani u/c GSSS Sarachi Distt Mandi and at present post of TGT (Arts) is lying vacant at GHS Baroha Distt. Bilaspur wherein 81 students are enrolled.

In view of above narrated circumstances, the representation of petitioner has been considered sympathically and the petitioner i.e. Sh. Naresh Kumar, TGT (Arts) is hereby transferred/adjusted from GHS Kalhani u/c GSSS Sarachi Distt Mandi to GHS Baroha Distt. Bilaspur against vacancy (without TTA/JT). The representation of the petitioner in the present CWP stands disposed of. All the concerned be intimated accordingly.
