Whereas, Smt. Reeta Devi, TGT (NM) preferred in CWP No. 2859/2025 titled as Reeta Devi, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Devi Kothi, Distt. Chamba, H.P (Hard Area) to nearby home station (Soft Area) in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 01-03-2025, when the Hon'ble High Court has passed the following orders:-

4. "Consequently, this Court without going into the merits of the case, desms it fit to dispose of the present petition, with a direction to the respondents to consider and decide the pending representation dated 14-02-2025 expeditiously, preferably within a period of two week, taking note of provisions contained in the transfer policy as well as observations made in the instant order. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an apportunity of hearing to the petitioner and pass appropriate order thereupon . Liberty is reserved to the petitioners to file appropriate proceedings in appropriate court of law, if he still remains aggrieved. Pending applications, if any, also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 22-03-2025. She attended the same and submitted her representation in this office, vide which She has requested that She has completed required tenure at her present place of posting at GSSS Devi Kothi, Distt. Chamba, H.P and She may be transferred to nearby native place in Distt. Kangra, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Devi Kothi, Distt. Chamba, H.P. since, 24-02-2022 which is a hard area and has completed her normal tenure at her present place of posting. One Sh. Sumesh Kumar, TGT(NM) is working in GSSS Nagrota Surian, Distt. Kangra, H.P. since 26-08-2022. The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and She is hereby transferred without TTA/JT from GSSS Devi Kothi, Distt. Chamba, H.P. to GSSS Nagrota Surian, Distt. Kangra, H.P. vice Sh. Sumesh Kumar, TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms. . With TTA/JT to Sh. Sumesh Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.


