Whereas, Sunil Kumar, TGT (NM) previously working in GSSS Girls Bilaspur, Distt. Bilaspur has filed CWP. No. 9749/2025- titled as, Sunil Kumar Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Bilaspur/Mandi. The case of the petitioner was listed before the Hon'ble High Court on 17.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"4. Having taken note of the fact that petitioner remained posted within the radius of 30 kms for a considerable time, this court is not persuaded to agree with aforesaid submissions of Mr. Jairath, however, having taken note of the adverse family circumstance as was apprised to this court, during proceedings of the case, this court deems it fit to dispose of the present petition with liberty to the petitioner to file representation within two days, praying therein for cancellation of transfer or adjustment at a convenient place, which in turn shall be decided by the competent authority within ten days. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of the transfer policy, which certainly enables an employee to seek transfer/adjustment at a convenient place on the ground of adverse family circumstances. Till the disposal of the representation, impugned transfer order, qua the petitioner shall be kept in abeyance. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 21.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may adjusted at GHS Gahar u/c GSSS Dadhol or GMS Thandora u/c GSSS Bharari or GSSS Behal or GMS Chhanhiar u/c GSSS Kathlag or GMS Bajaura u/c GSSS Nakhlehra or GSSS Dhawal or GSSS Chewa or GMS Kanoori u/c GSSS Chail, Distt. Bilaspur/Mandi/Solan against vacancy being caused due to retirement of present incumbent or against vacancy or against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GSSS Girls Bilaspur, Distt Bilaspur to GSSS Dofda, Distt. Shimla vide this directorate office order dated 04.06.2025 with the prior approval of the competent authority. At present, one post of TGT (NM) is going to be vacant at GMS Chhanjiar u/c GSSS Kathlag, Distt. Bilaspur on 30.09.2025 due to retirement of present incumbent.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted at GMS Chhanjiar u/c GSSS Kathlag, Distt. Bilaspur Distt. Bilaspur against vacancy being caused due to retirement of present incumbent on 30.09.2025, on his own request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
