In the matter of: CWP No. 8491/2025 titled as Amin Chand, TGT (NM) Vs. State of H.P & ors.

Whereas, Sh. Amin Chand, TGT (NM) who is u/t from GMS Jangal Jhalrda u/c GSSS Kandaur, Distt. Bilaspur to GSSS Deothi Balson, Distt. Shimla has filed CWP No. 8491/2025 titled as Amin Chand, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer/adjustment in Distt. Bilaspur, against vacancy/ longer stay. The above writ petition was listed before the Hon'ble High Court Himachal Pradesh on 22.05.2025 when the Hon'ble High Court has passed the following orders:-

5. "for the reasons stated hereinabove, without going into the merits of the case, present petition is disposed of, with a direction 3 to the respondents to issue fresh posting order of the petitioner within a period of one week, but while doing so, respondents may take note of the fact that petitioner has already served in tribal area for more than five years before his posting at Government Middle School, Jangal-Jhaleda, whereas private respondent always remained posted within the radius of 30 Km of his present place of posting. During the proceedings of the case, this Court also came to be apprised that one post of TGT(NM) is lying vacant at Government Middle School, Nehran u/c Government Senior Secondary School Kothi, District Bilaspur, Himachal Pradesh. If possible, respondent may consider transfer of the petitioner in the afore school or any other school in the vicinity. While doing the needful in terms of instant order, respondents shall afford an opportunity of hearing to the petitioner, if required. Since there is no fault, if any, of the petitioner, rather in compliance to transfer order dated 23.04.2025, he offered his joining, but same was refused, this Court sees no reason for withholding his salary and as such, respondents are also directed to ensure that salary, if any, payable to the petitioner, shall be paid/released expeditiously, preferably within a period of one week. Pending applications, if any, also stand disposed of."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 20.06.2025. He has attended the same and submitted his representation in this office on 20.06.2025 vide which he has requested that he has completed normal tenure at his present place of posting i.e GMS Jangal Jhalrda u/c GSSS Kandaur, Distt. Bilaspur to GSSS Deothi Balson, Distt. Shimla and he further requested that he may be transferred/adjusted in Distt. Bilaspur, against vacancy/ longer stayee. At present post of TGT (NM) are not lying vacant in the above mentioned school.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Jangal Jhalrda u/c GSSS Kandaur, Distt. Bilaspur H.P w.e.f. 31.12.2021 and under order of transfer to GSSS Deothi Balson, Distt. Shimla. At present the post of TGT (NM) is lying vacant at GMS Kanodi u/c GSSS Chail, Distt. Solan. The petitioner has given willingness for his transfer/adjustment at the aforesaid school against vacancy. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred/adjusted at GMS Kanodi u/c GSSS Chail, Distt. Solan, without TTA/JT. The representation of the petitioner is disposed of accordingly.
