
ORDER

Whereas vide this Directorate of even number dated 13-12-2024, the order/judgment passed by the Hon'ble High Court of H.P. in CWP No. 13014/2024-Ramna Devi TGT(Med.) V/s State of Himachal Pradesh & others had been considered and petitioner was transferred from GSSS Pajja (Chamba) to GSSS Forsythganj Distt. Kangra vice Sh. Rajinder Singh, TGT (Med.) and vice versa by clubbing his previous tenure.

And whereas Sh. Rajinder Singh, TGT (Med.), has represented on dated 29-12-2024 that he has already been served in the tribal/sub cadre area at GSSS Mangli Distt. Chamba and has requested for transfer/adjustment either at GHS Sidhbari, G(B)SSS Dharamshala or G(G) Dharamshala Distt. Kangra, against longer stayee by clubbing their previous posting tenure and his girl child is less than one year old and his wife is also working in this department as JBT.

And whereas the record has been re-examined and it is found that Sh. Rajinder Singh, TGT (Med.) is under order of transfer from GSSS Forsythganj Distt. Kangra to GSSS Pajja (Chamba) and has already been served in the sub cadre area at GSSS Mangli Distt. Chamba w.e.f. 24.08.2010 to 11.11.2014. At present the post of TGT (Med) are not lying vacant in above mentioned schools, however one Smt. Amita Kumari, TGT (Med.) is working in GSSS(B), Dharamshala District Kangra since 04.09.2023 and having short stay, but serving within the radius of 30 Kms. As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "all employees during their period of service will serve for at least single tenure in the Tribal/difficult/ Hard area and remote/rural areas.

And now keeping in view the position stated above the representation of Sh. Rajinder Singh, TGT (Med) is considered and as per provision in Clause 5.4 of Comprehensive Guiding Principles 2013 he is hereby adjusted from GSSS Pajja (Chamba) to G(B)SSS Dharamshala Distt. Kangra vice Smt. Amita Kumari, TGT (Med.) and vice versa (being longer stayee, with TTA/JT to Smt. Amita Kumari, TGT (Med.). With these observations the representation of Sh. Rajinder Singh, TGT (Med) is disposed of. All the concerned be intimated accordingly.
