## **ORDER**

In the matter of:

CWP No. 9785/2025- Smt. Upasna Sharma, TGT(NM) Vs. State of H.P. and others.

Whereas, Smt. Upasna Sharma, TGT(NM) previously working in GSSS Nalti, Distt. Hamirpur has CWPN0.9785/2025 titled as Smt. Upasana Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be adjusted at one of the stations of her choice in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 18.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"For the reason stated herein above, this court sees no reason to interfere in the impugned transfer order and such, same is upheld. However, having taken note of fact husband of the petitioner is also serving as Superintendent grade –II in the office Deputy Directorate, Hamirpur, this Court deems it fit to dispose of the present petition reserving liberty to the petitioner to file representation to the competent authority within two days for her adjustment at a convenient station on account of couple case, which shall be decided by the competent authority within ten days. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy, which certainly enables an employee to seek transfer/adjustment on the ground of couple case. Till the time, representation, as detailed herein above, is not decided in terms of instant order, petitioner-shall not be compelled to join at transferred station in terms of impugned transfer order.Pending applications, if any, stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 25.06.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be adjusted at GMS Jindwin u/c GSSS Didwin or GMS Sai u/c GHS Gulela or GMS Kanoh u/c GSSS Biar or GMS Chamned u/c GSSS Lambloo or GSSS Sohari, against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GSSS Nalti, Distt. Hamirpur to GSSS Kanda, Distt. Solan, against vacancy vide order dated 4.6.2025 with the prior approval of the competent authority. One, Sh. Rajesh Chand, TGT(NM) has been working in GMS Jindwin u/c GSSS Didwin, Distt. Hamirour since 17.02.2023. His previous place of posting at GMS Jamli u/c GSSS Mundkhar, Distt. Hamirpur where he worked w.e.f. 9.7.2020 to 17.02.2023 and has completed his normal tenure of three years within the radius of 30 KM.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby adjusted without TTA/JT at GMS Jindwin u/c GSSS Didwin vice Sh. Rajesh Kumar, TGT(NM), (as he has been working there since 9.07.2020 within the radius of 30 km) and vice versa with TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
