ORDER

In the matter of:-

CWP No. 9823/2025-titled as Babli, TGT (Arts) V/s. State of Himachal Pradesh.

The petitioner has filed present CWP No. 9823/2025 titled as Babli, TGT (Arts) V/s State of H.P. in the Hon'ble High Court against her transfer order dated 04.06.2025 on account of her mother in law heart disease and own health issues, she is unable to join at transferred station and sought her adjustment. The case was listed before the Hon'ble High Court of H.P. on 19.06.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"....having taken note of illness of the petitioner, this Court deems it fit to dispose of the present petition reserving liberty to the petitioner file representation to the competent authority within two days for her adjustment at a convenient station on medical grounds, which shall be decided by the competent authority within ten days. Ordered accordingly. Needless to say, authority concerneds while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy, which certainly enables an employee to seek transfer/adjustment on medical grounds. Till the time, representation, as detailed herein above, is not decided in terms of instant order, petitioner shall not be compelled to join at transferred station in terms of impugned transfer order."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on dated 18.7.2025 and appeared before the undersigned on the scheduled date. The petitioner has requested transfer/adjustment either to GMS Balla Ghirtholi/GSSS(G) Dharamshala/GSSS Khaniara Khas/GHS Jheol/Govt. (Nursery) Middle School Dharamshala Distt Kangra, citing that she is suffering from Chorinic Hepatitis and her Mother in law is suffering from heart disease.

From the perusal of record, it is found that Smt. Babli, TGT (Arts) has been posted at GHS Kand, Bagiara Distt. Kangra w.e.f. 30.4.2022 and her transfer order was issued to GSSS Sanooh Distt. Kangra vice Smt. Simmi, TGT(Arts) and vice versa basis on dated 04.06.2025. At present no post of TGT (Arts) is lying vacant in the petitioner choice of Schools, however one Sh. Navneet Gupta, TGT (Arts) is working at Govt. (Nursery) Middle School Dharamshala Distt Kangra since 27.04.2023 and having short stay but serving within the radius of 30 kilometers.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically. Accordingly, Smt. Babli, TGT (Arts), posted at GHS Kand Bagiara Distt. Kangra and u/t to GSSS Sanooh Distt. Kangra is hereby adjusted at Govt. (Nursery) Middle School Dharamshala Distt. Kangra vice Sh. Navneet Gupta, TGT (Arts) who may further be transferred to GSSS Sanooh Distt. Kangra, by clubbing his previous place of postings tenure (with TTA/JT to Sh. Navneet Gupta). The representation of the petitioner in the present CWP stands disposed of accordingly.
