**ORDER**

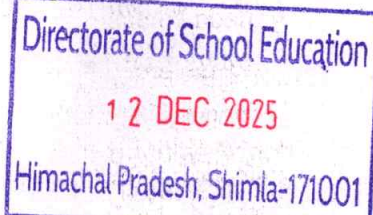
In the matter of:- CWP No. 17073/2025-titled as Vinod Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 17073 of 2025 in the Hon'ble High Court vide which sought his transfer from GHS Janglik, Distt. Shimla to soft area. The present CWP was listed before the Hon'ble High Court of H.P. on 03.11.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 21-11-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Vinod Kumar, TGT (Arts), submitted fresh representation and stated that he is working at GHS Janglik Distt. Shimla (hard area) and completed his normal tenure at present place of posting so that requested for transfer/adjustment at GSSS Nabahi, GHS Parsada Hawani, GSSS Bagragalu, GSSS Chhamyar GSSS Rewalsar or GSSS Chowk, Distt. Mandi.

From the perusal of the record, it is found that Sh. Vinod Kumar, TGT (Arts), is appointed on contract basis on dated 21.02.2022 and posted at GHS Janglik, Distt. Shimla (i.e. hard area) and his services are regularized on dated 15.07.2024, he has completed his normal tenure at present place of posting. At present one post of TGT (Arts) is lying vacant at GSSS Chowk, Distt. Mandi, wherein about 111 students are enrolled.

Keeping in view the position stated above, representation of the petitioner is considered sympathetically and Sh. Vinod Kumar, TGT (Arts) is hereby transferred from GHS Janglik Distt. Shimla to GSSS Chowk, Distt. Mandi against vacancy, without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of.
