ORDER

In the matter of: CWP No. 10166/2025-titled as Seema Kangoo (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Smt. Seema Kangoo, TGT (Med.) has filed CWP No. 10166/2025 titled as Seema Kangoo V/s. State of H.P. in the Hon'ble High Court, and seeking her transfer from O/o Deputy Director of elementary education Hamirpur in Inspection Cadre Distt. (Hamirpur to GSSS, GHS, Bhatara u/c GSSS, Chauri District Hamirpur against vacancy. The case was listed before the Hon'ble High Court of H.P. on 25.06.2025 on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Till such decision, the petitioner shall not be compelled to join at the transferred station and shall be at liberty to avail leave of the kind due. It is made clear that in case no such representation is made within the aforesaid period, interim protection granted to the petitioner shall stand automatically vacated. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In view of present case as well as representation of the petitioner Smt. Seema Kangoo TGT (Med.) was called for personal hearing on 03.02.2026 and she appeared before the undersigned on scheduled date and time. During personal hearing she has requested to adjust her at GHS, Bhatara u/c GSSS, Chauri District Hamirpur.

From the perusal of record, it is found that Smt. Seema Kangoo was under transferred from GHS, Chowki District Hamirpur to GSSS, Kunra District (Chamba) vide this directorate letter dated 19.06.2025 and further she was deputed in the O/o Deputy Director of Elementary Education Hamirpur in Inspection cadre District Hamirpur as per her request. At present no post of TGT (Med.) is lying vacant in GHS, Bhatara, District Hamirpur. However, one post of TGT (Med.) is lying vacant at GHS, Jansoo, District Hamirpur.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Seema Kangoo, TGT (Med.) is considered sympathetically and she is hereby adjusted at GHS, Jansoo District Hamirpur against vacancy, without TTA/JT. The representation of the petitioner is disposed of. All the concerned accordingly.
