It is made clear that in case no such representation is made within the aforesaid period, interim protection granted to the petitioner shall stand automatically vacated. Interim order dated 22.05.2025 shall stand vacated.

Kangra or GMS Dnar u/c GSSS Anni or GSSS Tikkar Khatrian, Distt. Hamirpur, against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Ludret u/c GSSS Darkota at Barial, Distt. Kangra to GSSS Nagali Banikhet, Distt. Chamba vice Sh. Sanjay Kumar, TGT(NM) vide order dated 20.05.2025 with the prior approval of the competent authority. GSSS Nagali Banikhet falls in soft area. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration.

Whereas, Virender Kumar, TGT (NM) presently working in GSSS Dandroo, Distt. Hamirpur has filed CWP. No. 9353/2025- titled as Virender Kumar, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the station at his choice in Distt. Bilaspur/Hamirpur/Una. The case of the petitioner was listed before the Hon'ble High Court on 30.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Since the petitioner has worked for almost 5 years within the radius of 30 kms, no illegality can be said to have been committed by the respondents while passing the impugned transfer order. However, having taken note of adverse family circumstances, which came to be apprised to this Court during the proceedings of this case, the present petition is disposed of by reserving liberty to the petitioner to make a detailed presentation to the competent authority within two days, seeking transfer/adjustment at a convenient place on account of adverse family circumstances, which shall be decided by the aforesaid authority within one week thereafter. Needless to say, the authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereafter. 6 Till the time, the representation is not decided, the petitioner shall not be compelled to join at the transferred station, but he shall stand relieved from the present place of posting and as a consequence thereof, the private respondent would start getting salary. Pending application(s), if any, also stands disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 14.08.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Dandroo, Distt. Hamirpur to GHS panyali or GSSS Daslehra or GMS Sakri u/c GSSS Maharal or GSSS Gharan or GSSS Bheri or GSSS Bangana or GHS Gahar u/c GSSS Dadhol or GSSS Dhundla Distt. Bilaspur/Hamirpur/Una against longer stayee or against vacancy being caused due to promotion of TGTs.

From the perusal of record, it is found that Sh. Virender Kumar TGT (NM) has been posted at GSSS Dandroo, Distt. Hamirpur w.e.f. 02.08.2021 and serving within the radius of 30 KM. The transfer order of Sh. Virender Kumar, TGT (NM) from GSSS Dandroo, Distt. Hamirpur to GHS Gundah u/c GSSS Bakras, Distt. Sirmour by clubbing his previous place of posting/tenure. Furthermore, Sh. Virender Kumar, TGT (NM) has not previously served in a hard or tribal area. The Hon'ble High Court's judgment in CWP No. 2734/2024, titled Monika Katna Vs. State of HP, upheld the legality and validity of the office memorandum dated 27.10.2023, which provides for the clubbing of stay for transfer purposes. The Court clarified that such clubbing is not contrary to Clouse-10 of the Transfer Policy of the State Government. Additionally, in CWP No. 10255/2025, titled Bharti Rathour Vs. State of HP, the Hon'ble High Court emphasized that all departments must ensure that each employee is assigned to a subcadre or tribal area at least once during their service career.

In view of above narrated facts and as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of chice cannot be claimed as a matter of right." Therefore, being a State cadre Government employee, the request of the petitioner is not tenable and hereby rejected. The representation of the petitioner with the present CWP is disposed of accordingly.

## **ORDER**

In the matter of : CWP No. 8805/2025 titled as Nandika Sharma& ors. vs. State of HP and others.

Whereas, the petitioners in the above court case have filed CWP No. 8805 of 2025 titled as Nandika Sharma& ors. vs. State of HP and others in the Hon'ble High Court which was disposed of by the Hon'ble High Court on 04.06.2025 with the following judgment:-

"Before replyif any, from the respondents could be received, learned counsel representing the petitioners, while inviting attention of this Court to judgment dated 28.05.2024 passed by Coordinate Bench of this Court in CWP No. 2171 of 2023 titled as Hem Raj Vs. State of H.P. and others, alongwith connected matters, states that issue raised in the instant proceedings already stands adjudicated by Coordinate Bench of this Court in Hem Raj (supra) as such, petitioner would be content and satisfied in case directions are issued to the respondents to consider the representation of the petitioner in light of aforesaid judgment in a time bound manner.

- 2. While putting in appearance on behalf of respondents, Mr. Vishal Panwar, learned Additional Advocate General, fairly states that representation, if any, filed by the petitioners shall be considered and decided expeditiously.
- 3. Consequently, in view of the aforesaid fair stand adopted by learned Additional Advocate General, coupled with the fact that petitioners have already filed representation for redressal of their grievances (Annexure P-3), this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the representation of the petitioners in light of judgment passed by this Court in Hem Raj (supra), expeditiously, preferably within a period of six weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioners and pass speaking order thereafter. Pending applications, if any, stand disposed of".

Whereas, in compliance to the above judgment passed by the Hon'ble High Court the petitioners were called for personal hearing on 31.07.2025 and heard in length. During course of hearing the petitioners requested that their case may kindly be considered in the light of the above judgment.

Whereas, the petitioner in present petition has represented that their case may kindly be considered in light of the judgment passed by the Hon'ble High Court of HP in CWP No. 2171/2023 titled as Hem Raj & others vs. State of HP and they may kindly be granted the pay scale of TGT (Hindi/Sanskrit).

Whereas, the case of the petitioners has been examined in compliance to the judgment passed in CWP No. 2171/2023 titled as Hem Raj vs. State of HP and taking into consideration the Notification of the Government issued vide No. EDC-B(15)15/2011 dated 20-08-2022 which says, "all Bachelor of Education (B.Ed.) qualified and Teacher Eligibility Test (TET) passed Shastris and Language Teachers(LTs) are to be designated as Trained Graduate Teachers

(Sanskrit) and Trained Graduate Teachers (Hindi) in their respective pay scale structure." • Therefore, no financial benefits were granted to these categories, and merely their nomenclature was changed to TGT (Sanskrit) and TGT(Hindi) and that too for only those Shastri/Language Teachers who are B.Ed. qualified and FET pass.

Whereas, the Hon'ble High Court in the said CWP No. 2171/2023, has passed the following judgment on 04-09-2023 at Para 7:-

"In view of the discussion in para 5 above, these writ petitions are allowed. The respondents are directed to grant the pay scale of the post of Trained Graduate Teachers(TGTs) and promotional avenue to the post of Lecturer(School New) to the petitioners (Shastri (Sanskrit) and Language Teacher (Hindi)- now-redesignated as TGT(Sanskrit) and TGT(Hindi) respectively, in terms of notification dated 20-08-2022, as is being given to TGT(Medical), TGT(Non- Medical), and TGT(Art). This shall be admissible to them from the date of issuance of notification dated 20.08.2022. The exercise be completed within seven weeks from today, miscellaneous applications, if any, also stand disposed of."

Whereas, the matter of Sh. Hem Raj & others has already been examined at Govt. level in compliance to the judgment passed by the Hon'ble High Court in CWP No. 2171/2023 titled as Hem Raj vs. State of HP, CWP No. 8389/2023 to 8398 of 2023 alongwith others connected matters and Execution Petition No. 168 & 170 of 2024 and thereafter the Govt. has passed detailed speaking orders on 20.05.2024 and subsequently addendum on 17.09.2024. Operative part of speaking order is as under:-

"Whereas, Execution Petition No. 168 & 170 of 2024 were further filed in this matter in the Hon'ble High Court & the Hon'ble Court vide order dated 19.03.2024 had directed to decide the representation within a period of six weeks.

Thus, as per the directions of the Hon'ble High Court in above mentioned CWPs & Execution Petitions, their representation dated 18-03-2023 of State President Rajkiya Bhashai Adhyapak Sangh, Himachal Pradesh has been examined and considered by the undersigned. It has been found that their main prayer is to consider the candidature of re-designated TGT (Hindi and TGT (Sanskrit) in the panel for promotion to the next higher posts i.e. Lecturer/headmaster, as the panel of eligible officials are being prepared by the Deputy Directors (Elementary Education).

It would be pertinent to mention here that the petitioners have been working as Shastri & Language Teachers in the Elementary Education Department and they were redesignated as TGT (Sanskrit) and TGT (Hindi) in their respective scales vide Notification dated 20-08-2022. Since, they have re-designated as TGTs vide the notification mentioned supra, the pay scales and promotional avenues are admissible to them from the date of issuance of said notification i.e. 20.08.2022. The orders of Hon'ble High Court as mentioned in para 3 above also direct the same.

Thus, after considering the whole matter, I am of considered view that such redesignated TGTs (Sanskrit/Hindi) are entitled to be considered for promotion as Lecturers/Headmasters and thus they are considered for the same. However, tenure or service of such re-designated Sanskrit/Hindi Teachers as TGT shall be considered from the date of their redesignation as TGTs which in this case, is the date of notification dated 20-08-2022. It is pertinent to mention that as per the R&P Rules for the post of Lecturer (School-New) and Headmaster, there is specified period of minimum length of service as TGT (5/8 years) for a

candidate to become eligible for promotion. Thus, these teachers shall become eligible for promotion only after completion of required length of service which is to be counted w.e.f. 20.08.2022, subject to the final outcome of LPA No. 86/2024 (State Vs. Hem Raj)"

It is pertinent to mention here that above judgment passed in the Hem Raj case under CWP No. 2171/2023 has been assailed by the Department by way of filing the LPANo. 86/2024 in the Hon'ble High Court which has also been admitted in the Hon'ble High Court.

Therefore, after considering the whole matter, the petitioner is hereby considered only for promotion as Lecturer/Headmaster subject to final outcome of LPA No. 86/2024. However, tenure or service of the petitioner shall be considered from the date of his re-designation as TGT i.e. the date of notification dated 20-08-2022 or from the date of passing of TET/B.Ed examination which is later. It is pertinent to mention that as per the R&P Rules for the post of Lecturer (School-New) and Headmaster, wherein specified period of minimum length of service as TGT(5/8 years) for a candidate to become eligible for promotion. Thus, the petitioner shall become eligible for promotion only after completion of required length of service which is to be counted w.e.f. 20.08.2022 or from the date of passing of TET/B.Ed examination which is later.

Hence, the representation of the petitioners is hereby considered and decided accordingly.
