

Whereas, Smt. Monika Kumari, TGT(NM) presently working in GHS Tepar u/c GSSS Nau Pnau, Distt. Mandi has filed CWP No.14348/2025 titled as Monika Kumari Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be transferred from GHS Tepar u/c GSSS Nau Pnau, Distt. Mandi to one of the stations of her choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 04.09.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Looking to the nature of the grievance raised in this writ petition, it would in the interest of justice to direct Competent Authority to consider and decide the aforesaid representations (Annexure P-3 & P-4) of the petitioner in accordance with law and as per applicable policy within a period of four weeks from today. Ordered accordingly. The order so passed be also communicated to the petitioner. The writ petition stands disposed of in the above terms. All pending miscellaneous application(s), if any, to also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the perusal of Annexure P-3, P-4(Representations) reveals that the petitioner is desiring for her transfer from GHS Tepar u/c GSSS Nau Pnau, Distt. Mandi to GMS Karha pura u/c GSSS Dhaloon or GSSS(Girls) Nagrota Bagwan or GHS Manjha, Distt. Kangra, against vacancy being a couple case.

Whereas, Smt. Mangla Devi, TGT(NM) presently working in GSSS Kamlar, Distt. Sirmour has filed CWP No.13274/2025 titled as Mangla Devi Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be transferred from GSSS Kamlar, Distt. Sirmour to one of the stations of her choice in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 19.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Keeping in view above, the impugned order dated 24.07.2025 is quashed and set aside. The petitioner is permitted to move a fresh comprehensive representation along with her husband-Sh. Shashi Kant within one week seeking transfer from their respective places of posting to the respondent No.2-Competent authority. In case, such representation is so made, the same shall be considered by the respondent No.2/competent authority, in accordance with law and applicable transfer policy, keeping in view observation made above within two weeks thereafter. The order so passed shall also be communicated to the petitioner. The instant petition is disposed of in above terms. Pending miscellaneous application(s), if any, shall also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner and her husband- Sh. Shashi Kant, TGT(NM) were called for personal hearing on 03.09.2025 and both of them appeared in person. During the course of hearing, the petitioner stated that her husband is serving in GMSSS Baldwara, Distt. Mandi and requested that she may be transferred from GSSS Kamlar, Distt. Sirmour to GSSS Patta or GSSS Loharli or GGHS Dhaneta or GSSS Sathwin or any vacant post in Distt. Hamirpur being a couple case. Sh. Shashi Kant, TGT(NM) requested that he may be transferred from GMSSS Baldwara, Distt. Mandi to GMS Khagal or GMS Nara or GMS Kot or any vacant post in Distt. Hamirpur or Tehsil Bangana in Distt. Una.

After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS Kamlar, Distt. Sirmour since 22.02.2022 on regular basis and has completed her normal tenure of three years. In the transfer policy at clause No. 5.4 it has been mentioned that in case wife and husband both are working under the State Government, efforts should be made to post them at one place or near places as far as possible, subject to vacancy. At present, one post of TGT(M) is lying vacant at GSSS Brang, Distt. Mandi.

Therefore, keeping in view the clause mentioned in the transfer policy elaborated hereinabove in the above para, Smt. Mangla Devi, TGT(M) is hereby transferred from GSSS Kamlar, Distt. Sirmour to GSSS Brang, Distt. Mandi against vacancy being couple case.
