ORDER

In the matter of: CWP No. 3462/2025-titled as Shilpa Kumari, TGT (Arts) V/s. State of Himachal Pradesh.

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 3462/2025-titled as Shilpa Kumari, TGT (Arts) V/s State of H.P. on 13.03.2025, the petitioner was called for personal hearing on 24-03-2025 and appeared before the undersigned on scheduled date. The petitioner has stated that she has completed her normal tenure in hard/difficult area and having old age mother and father in law who are suffering from various old age ailments, therefore, requested for her transfer either to GSSS Bohar Kwalu/GSSS Thana Bargran/GSSS Birta/ GHS Jalari/ GHS Takipur/ GHS Bandal Distt Kangra against vacancy caused due to retirement or against longer stayee.

From the perusal of record, it is found that Smt. Shilpa Kumari, TGT (Arts) is working at GMS Nikanh u/c GSSS Ladda (Hard area) District Chamba since 04-03-2022 and has completed her normal tenure in hard area. At present one post of TGT (Arts) is going to be vacant at GSSS Bohar Kwalu, District Kangra, due to retirement of present incumbent on 31.03.2025.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Shilpa Kumari, TGT (Arts) is considered sympathetically as per transfer policy and petitioner is hereby transferred from GMS Nikanh u/c GSSS Ladda, district Chamba to GSSS Bohar Kwalu, district Kangra against vacancy, being caused due to the retirement of present incumbent on 31.03.2025, without TTA/JT, The petitioner will join after superannuation of present incumbent. Therefore, representation of the petitioner with the present CWP is disposed of accordingly.
