Whereas, Mohinder Singh, TGT (NM) previously working in GMS Rambho, Distt. Chamba has filed CWP. No. 12231/2025- titled as Mohinder Singh, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 29.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"4. Having taken note of the fact that petitioner has already completed four years at Government Middle School, Rambho, which is a hard area, coupled with the fact that transfer policy enables an employee, who is working in hard area, to seek transfer in soft area or one of the station of his choice, this Court deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the representation dated 23.07.2025 (Annexure P-4) having been filed by the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 14.08.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GHS Kand or GSSS Mandal or GHS Dandomb or GSSS Jalag or GSSS Kotwali Bazar against longer stayee or against vacancy.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Rambho u/c GMSSS Mehla, Distt. Chamba to GMS Uchka u/c GSSS Lylh, Distt. Chamba vide this office letter No. even dated 01.05.2025 with the prior approval of competent authority. One, Smt Saroj Kumari, TGT (NM) has been working in GHS Kand u/c GSSS Dari, Distt. Kangra since 20.03.2025 and her previous place of posting was GSSS Ghaniara, Distt. Kangra where she worked 06.01.2022 to 19.03.2025 and has completed her normal tenure of three years within the radius 30 KM.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted at GHS Kand u/c GSSS Dari, Distt. Kangra without TTA/JT vice Saroj Kumari, TGT (NM) and vice versa with TTA/JT. The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
