ORDER.

In the matter : CWP No. 1799/2026 titled as Pushap Lata, TGT(Med) VS State of H.P. others.

The Petitioner Smt. Pushap Lata, TGT(Med) filed CWP No. 1799/2026 titled as, Smt. Pushap Lata, TGT(Med) Vs. State of H.P. before the Hon'ble High Court of H.P. and seeking her transfer from GSSS, Bagshar Distt. Mandi to District Kangra. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 11.02.2026 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"The respondents are directed to take a decision on the representation (Annexure P-5) filed by the petitioner within a period of two weeks from today and the said order shall be communicated to the petitioner by the respondents.

It is made clear that this Court has not expressed any opinion on the merits of the case and the respondent shall take a decision on the representation strictly in accordance with the law."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 28.02.2026. The petitioner attended the personal hearing scheduled date and time and has submitted representation to adjust her at district Kangra.

From the perusal of the record, it reveals that Smt. Pushap Lata, TGT (Med.) is working in GSSS, Bagshar District Mandi since 27.02.2021 and has completed his normal tenure at present place of posting. Moreover, GSSS, Bagshar District Mandi falls in soft area.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
