"ORDER"

Whereas the petitioner Sh/ Ashwani Kumar Chadda, Lect./Lect.(SN)

Physics under order of transfer from GSSS Paonta, (Mandi) to GSSS Devdhar, (Mandi) earlier issued on dated 31.05.2025. Feeling aggrieved he filed CWP No 9359/2025 titled as Ashwani Kumar Chadda Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 18.06.2025 when the same was finally disposed with the directions to respondents as under:-

"Consequently, in view of the above, this Court sees no reason to interfere in the impugned transfer order and as such, same is upheld, however having taken note of the fact that petitioner is about to retire within two years, this court deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation to the competent authority, praying therein for his adjustment at a convenient place, within three days, which in turn shall be decided by the competent authority within ten days. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a seeking order taking note of the transfer policy, which certainly enables as employee nearing retirement to seek transfer/adjustment at a convenient place. Pending applications, if any, also stand disposed of.

And whereas upon passing of above directions, the representation of petitioner has been perused and examined and it has been observed that he has requested for his adjustment either at GSSS Bhareri, (Hamirpur)/ GSSS Bhambla, (Mandi)/ GSSS Ladraur, (Hamirpur)/ GSSS Baldwara, (Mandi)/ GSSS Bhota, (Hamirpur)/ GSSS Pairi, (Mandi) against vacancy or longer stayee by clubbing previous stay of present incumbent.

And whereas as per direction passed by the Hon' ble High Court as above, the applicant was called to appear in this office for personal hearing on 21.07.2025 and was present on this date. During the course of hearing the applicant has pleaded that as there are less than two years left for his retirement. At present there is only one station i.e GSSS Pairi, (Mandi) is lying vacant where the petitioner seeking his adjustment.

And whereas, now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and the petitioner i.e Sh. Ashweani Kumar Chadda, Lect./Lect.(SN) Physics is being adjusted at GSSS Pairi, Distt. Mandi against vacancy. Accordingly his representation stand disposed of.
