ORDER

In the matter of: CWP No. 8934/2025- Sh. Sanjeev Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Sanjeev Kumar, TGT(NM) presently working in GSSS GSSS Seikothi, Distt. Chamba has CWP No. 8934/2025 titled as Sh. Sanjeev Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Seikothi, Distt. Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 28.05.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Grievance of the petitioner is that he is serving as TGT (N.M) at GSSS Seikothi, Tehsil Churah, District Chamba, HP ever since 18.11.2019. He has completed much more than requisite tenure in the aforesaid hard/tribal area and is seeking his transfer to a station of his choice in accordance with the Transfer Policy. In this regard, he has preferred representation dated 24.04.2025 (Annexure P-4) to the respondent /Competent Authority, however, the same has not been decided the respondent/Competent Authority till date.

Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent /Competent Authority to consider and decide the aforesaid representation of the petitioner in accordance with law and as per transfer policy within a period of three weeks from today. The decision so taken be also communicated to the petitioner. Pending miscellaneous application(s), if any, also stand disposed of.

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 19.06.2025 but the petitioner did not appear. However, another opportunity was granted to the petitioner on 03.07.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSS Seikothi, Distt. Chamba(Hard area) to GSSS Sullah or GSSS Kandwari or GHS Rajehar or GMS Patti u/c GMSSS Rajpur or GSSS Banuri, Distt. Kangra against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS Seikothi, Distt. Chamba since 18.09.2019 and has completed his normal tenure at his present place of posting. One, Sh. Rajesh Kumar, TGT(NM) has been working in GSSS Sullah, Distt. Kangra since 29.02.2024. His previous place of posting was GHS Arth u/c GSSS Lahla, Distt. Kangra where he worked w.e.f .06.12.2021 to 28.02.2024 and has completed his normal tenure of three years within the radius of 30 KM.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Seikothi, Distt. Chamba to GSSS Sullah, Distt. Kangra vice Sh. Rajesh Kumar, TGT(NM), (as he has been working there since 06.12.2021 within the radius of 30 km) and vice versa with TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
