ORDER

In the matter of:- CWP No. 12442/2025-titled as Suman Kumar, TGT (Arts) V/s. State of HP.


The petitioner has filed present CWP in the Hon'ble High Court vide which sought his transfer from GHS Kuned u/c GSSS Lylh, Distt. Chamba to one of the station of his choice. The present CWP was listed before the Hon'ble High Court of H.P. on 31st July 2025, on this day Hon'ble Court has passed order/judgment, the operative portion is as under:-

".....the present petition is disposed of by permitting the petitioner to make fresh comprehensive representation to the respondents /Competent Authority indicating stations of choice, where he can be adjusted, within a period of one week from today, who shall in turn, consider and decide the same, in accordance with law and transfer policy, within a further period of three weeks by passing order, which shall also be communicated to the petitioner."

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 09-09-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Suman Kumar, TGT (Arts), submitted that he has completed normal tenure at present place of posting which falls in Sub-Cadre/Hard Area and also facing adverse family circumstances, as his parents are old age and suffering from various old age ailments and no one in the family of the petitioner to look after them.

From the perusal of record, it is found that Sh. Suman Kumar, TGT (Arts), is working at GHS Kuned u/c GSSS Lylh, Distt. Chamba since 23.02.2022 & as such completed his normal stay. At present one post of TGT (Arts) is lying vacant at GSSS Pathiar, Distt. Kangra wherein 209 students are enrolled during current academic session. Keeping in view the position stated above, representation of the petitioner is considered sympathetically and the petitioner Sh. Suman Kumar, TGT Arts is hereby transferred/adjusted from GHS Kuned u/c GSSS Lylh, Distt. Chamba to GSSS Pathiar, Distt. Kangra against vacancy (without TTA/JT).

The representation of the petitioner in the present CWP stands disposed of. All the concerned be intimated accordingly.
