ORDER.

The Petitioner Sh. Munish Bakshi, TGT(Med)) filed CWP No. 16601/2025 titled as, Sh. Munish Bakshi, TGT(Med) Vs State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS, Teshan u/c GSSS, Baragaon Distt. (Sml.) to GSSS, Tiara and GSSS, Hatwa Distt. (Kangra). The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 28.10.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Though this Court finds that petitioner has not completed normal tenure at present place of posting, but since Transfer Policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer/adjustment from one station to another on account of adverse family circumstances, there appears to be impediment in issuing direction to the respondents to consider and decide the pending representation of the petitioner expeditiously, preferably within three weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful, in terms of instant order, shall afford an opportunity of being heard to the petitioner an pass appropriate orders taking note of adverse family circumstances of the petitioner. Pending application(s), if any, stand disposed of.

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 14.11.2025. The petitioner attended the personal hearing on scheduled date and time. During personal hearing he has requested to adjust him at GSSS, Tiara and GSSS, Hatwa Distt. (Kangra) against vacancy.

From perusal of the record, it is observed that Sh. Munish Kumar, TGT (Medical) is working in GHS, Teshan u/c GSSS Baragaon Distt. (Sml.) since 03.10.2023 and has not completed the normal tenure at his present place of posting.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
