ORDER

In the matter of:

CWP No. 146/2025-titled as Smt. Vandna (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Smt. Vandna, TGT (Med.) has filed CWP No. 146/2025 titled as Vandna V/s. State of H.P. in the Hon'ble High Court, and seeking her transfer from GHS, Sarma U/c GSSS, Bani Materni Distt. Solan to GHS, Menjha, GSSS Upper Lambagaon, GHS, Jhunga Devi U/c GSSS Upper Lambagaon, GHS, Thandol, GHS, Gopalpur u/c GSSS Jia, SPK GMSSS, Chachian, GSSS, Chowki Khalet, GSSS, Averi, GHS Haler Distt. Kangra against longer stay or by clubbing their previous stay. The case was listed before the Hon'ble High Court of H.P. on 04.01.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Looking nto the nature of the grievance raised in this writ petition, it would in the interest of justice to direct respondent No.2/competent authority to consider and decide the aforesaid representation (Annexure P-2) of the petitioner in accordance with law and as per applicable policy within a period of four weeks from today. Ordered accordingly. The order so passed be also communicated to the petitioner."

The petitioner i.e Smt. Vandna, TGT (Med.) was called for personal hearing and she appeared before the undersigned on 22.02.2025. At the time of hearing she has submitted fresh representation vide which she stated that due to her husband demise, she is a single parent to her minor daughter, who is residing with her in-laws and parents in Kangra. So, she has requested to adjust her at GHS, Menjha, GSSS Upper Lambagaon, GHS, Jhunga Devi U/c GSSS Upper Lambagaon, GHS, Thandol, GHS Gopalpur u/c GSSS Jia, SPK GMSSS Chachian, GSSS, Chowki Khalet, GSSS, Averi, GHS Haler against longer stay or by clubbing their previous stay.

From the perusal of record, it is found that Smt. Vandna, TGT (Med.) is working at GHS, Sarma U/c GSSS, Bani Materni Distt. Solan since 23.12.2020 and she has completed her normal tenure at present place of posting as per transfer policy.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Vandna, TGT (Med.) is considered sympathetically and petitioner is hereby transferred from GHS, Sarma u/c GSSS, Bani Materni Distt. Solan to GHS, Menjha Distt. Kangra vice Smt. Nishu Sehgal TGT (Med.) (By clubbing her previous stay) with TTA/JT to Smt. Nishu Sehgal. Keeping in view the position stated above, representation of the petitioner i.e Smt. Vandna, TGT (Med.) is disposed of accordingly.
