## ORDER

In the matter of:-

CWP No. 8354/2025-titled as Anurag Pradhan, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court of HP and sought his transfer from GHS Jammuhar u/c GSSS Luddu Distt Chamba to a soft station of his choice. The case was listed before the Hon'ble High Court of H.P. on 21.05.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"....Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing the respondents/competent authority to consider and decide the aforesaid representation of the petitioner dated 13.03.2025 (Annexure P-3) in accordance with law and applicable transfer policy within a period of three weeks from today. The decision so arrived at shall also be communicated to the petitioner."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on dated 18.7.2025 and appeared before the undersigned on the scheduled date. The petitioner (Sh. Anurag Pradhan, TGT (Arts) has requested transfer/adjustment either to GSSS Rakkar/GBSSS Dharamshala Distt. Kangra against vacancy being caused due to retirement of present incumbent on 31.08.2025, citing that he has completed normal tenure of posting in sub cadre area of Distt. Chamba.

From the perusal of record, it is found that Sh. Anurag Pradhan, TGT (Arts) has been posted at from GHS Jammuhar u/c GSSS Luddu Distt Chamba w.e.f. 19.06.2015 and he has completed his normal tenure at present place of posting(i.e. sub cadre area). At present one post of TGT (Arts) is going to vacant at GSSS Rakkar, Distt. Kangra on 31.08.2025 wherein about 115 students are enrolled.

Keeping in view the position stated above, representation of the petitioner i.e Sh. Anurag Pradhan, TGT (Arts) is considered sympathetically and he is hereby transferred from GHS Jammuhar u/c GSSS Luddu Distt Chamba to GSSS Rakkar Distt Kangra against vacancy, being caused due to the retirement of present incumbent on 31-08-2025, without TTA/JT. The petitioner will join after superannuation of present incumbent i.e. after 31-08-2025. Therefore, representation of the petitioner with the present CWP disposed of accordingly.

## **ORDER**

In the matter of:-

CWP No. 8724/2025-titled as Lata Kumari, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 8724/2025 titled as Lata Kumari, TGT (Arts) V/s State of H.P. in the Hon'ble High Court against her transfer order dated 17.05.2025 from GHS Bumbloo Distt. Hamirpur to GSSS Ghoond Distt. Shimla and sought her adjustment. The case was listed before the Hon'ble High Court of H.P. on 26.05.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"In view of above, this writ petition is disposed of without interfering transfer of respondent No.3 under the impugned office order dated 17.05.2025, but reserving liberty to the petitioner to prefer a representation to the respondents/competent authority within two days. In case representation is made within the aforesaid timeline, the same shall be decided within one week, in accordance with law and applicable policy. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on dated 18.7.2025 and appeared before the undersigned on the scheduled date. The petitioner has submitted that she had joined at transferred station GSSS Ghoond Distt. Shimla on 13.06.2025 further she has requested her transfer at GSSS Matahani Distt. Hamirpur, citing that her husband is serving as Associate Professor at GDC Hamirpur.

From the perusal of record, it is found that Smt. Lata Kumari, TGT (Arts) has been posted at GHS Bumbloo Distt. Hamirpur w.e.f. 13.07.2021 and her transfer order was issued to GSSS Ghoond Distt. Shimla on dated 17.05.2025. The petitioner has completed her normal tenure at GHS Bumbloo Distt. Hamirpur and she had joined her services at transferred station on 13.7.2025 and having short stay. It is important to highlight that the student enrollment of GSSS Ghoond stands at 55, and the institution is classified as a soft area within District Shimla. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right.

Keeping in view of the above facts and circumstances, the representation/case of the petitioner for adjustment cannot be considered at this stage as the petitioner has already been joined at transferee school i.e. GSSS Ghoond Distt. Shimla. Hence, the representation of the petitioner is disposed of accordingly.
