ORDER

Whereas, the petitioner namely Sh.Kishori Lal, Lect(History) who is under transfer from GSSS Trifalghat (Mnd) to GSSS Balag (Mnd), has filed CWP No. 10565/2025 titled as Kishori Lal vs State of HP before the Hon'ble High Court seeking therein relief regarding his adjustment due to his adverse family circumstances. This case was listed on 03.07.2025 when the Hon'ble Court has given following directions:-

For the reasons stated hereinabove, though this Court sees no reason to interfere with the impugned transfer order, however, having taken note of adverse family circumstances of the petitioner, as came to be apprised to this Court during proceedings of the case, this Court deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation of the petitioner (Annexure P-4), expeditiously, preferably, within a period of ten days, taking note of Transfer Policy, formulated by the Government of Himachal Pradesh, which certainly enables an employee to seek transfer at a convenient station on account of adverse family circumstances. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass detailed speaking order thereupon. Till the time, representation, as detailed hereinabove, is not decided by the competent authority, petitioner shall not be compelled to join at the transferred station.

Pending applications, if any, also stand disposed of

And whereas, in compliance of Hon'ble High Court order dated 03.07.2025 the petitioner was called for personal hearing on 23.07.2025 and he was heard in person. During the course of hearing he has requested that he is unable to joined at GSSS Balag (Mnd) due to his adverse family circumstance and further requested to adjust him at GSSS Dumehar, GSSS Chharol, and GSSS Maithi Distt. Bilaspur against vacancy.

And whereas, while examined his representation it is found that petitioner was transferred from soft station to soft station and enrollment of student is 32 in the said subject there. Moreover, he was serving within the radius of 6-8 Kms approximately since 2020 and as per para 12.1 of "Comprehensive Guiding Principals-2013" the transfer of the Government employees, it is clearly mentioned that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/ transfer any employee anywhere in the state keeping in view of the administrative exigencies/ convenience.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected and his transfer orders dated 17.05.2025 shall stand.

With these observations, representation stands disposed of.



He has filed CWP No. 9759/2025 titled as Pawan Kumar vs State of HP before the Hon'ble High Court seeking therein relief regarding his transfer due to served his hard area. This petition was listed on 18.06.2025 when the Hon'ble Court has given following directions:-

Consequently, in view of the above, present petition is disposed of with a direction to the respondents to consider and decide the pending representation (Annexure P-3) of the petitioner expeditiously, preferably within a period of four weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy formulated by the Government of Himachal Pradesh, which provides for transfer of an employee from hard area to soft area after his/her completion of normal tenure of posting i.e. two winters and three summers. Pending applications, if any, stand disposed of.

And whereas, in compliance of Hon'ble High Court order dated 18.06.2025 the representation of petitioner has been perused and examined and it has been abserved that he has requested for his adjustment at GSSS Neul (Klu) against vacancy.

And whereas, as per direction passed by the Hon'ble High Court as above, the applicant was called to appear in this office for personal hearing on dated 23.07.205 and was present on this date. During the course of hearing the applicant has pleaded that his relief as though the petitioner served at the said school which is fall in hard area.

Now therefore, after taking into account the above discussed detailed facts and circumstances, representation has been considered and allowed. The petitioner i.e Sh.Pawan Kumar, Lect.(History) is being transferred from GSSS Multhan (Kgr) to GSSS Neul (Kullu) against vacancy. Hence representation stands disposed of.
