ORDER

In the matter of: CWP No. 4515/2025 titled as Sanjay Kumar, TGT (NM) Vs. State of H.P. & others.

Whereas, Sh. Sanjay Kumar, TGT (NM) previously working in GMS Dushad u/c GSSS Sainj, Distt. Kullu has filed CWP No. 4515/2025 titled as Sanjay Kumar, TGT (NM) Vs. State of H.P & others. before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Bilaspur. The case of the petitioner was listed before the Hon'ble High Court on 27.03.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

Consequently in view of the above, this Court without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation 10.01.2025 (Annexure P-3) of the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while doing needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon, taking note of the transfer policy framed by Government of Himachal Pradesh. Liberty is also reserved to the petitioner to file appropriate proceedings in appropriate court of law, if he still remains aggrieved. Pending applications, if any, also stand disposed of.

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 19.06.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GMS Thandora u/c GSSS Bharari Distt. Bilaspur against vacancy being caused due to retirement of present incumbent.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Dushad u/c GSSS Sainj, Distt Kullu to GMS Bhupan U/c GSSS Raila, Distt. Kullu vide order dated 22.05.2025 with the prior approval of the competent authority. At present, one post of TGT (NM) is lying vacant at GMS Thandora u/c GSSS Bharari, Distt. Bilaspur.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted without TTA/JT at GMS Thandora u/c GSSS Bharari, Distt. Bilaspur against vacancy being caused due to retirement of present incumbent, on his own request.

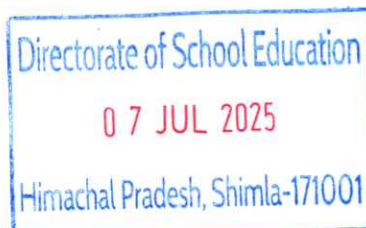
Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
