## **ORDER**

In the matter of:

CWP No. 6250/2025- Sh. Rajesh Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Rajesh Kumar, TGT(NM) presently working in GSSS Lylh, Distt. Chamba has filed CWPNo.6250/2025 titled as Sh. Rajesh Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Lylh, Distt. Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 21.04.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Looking to the nature of the grievance raised in this writ petition, it would in the interest of justice to direct respondent No.2/competent authority to consider and decide the aforesaid representation (Annexure P-2) of the petitioner in accordance with law and as per applicable policy within a period of three weeks from today. Ordered accordingly. The order so passed be also communicated to the petitioner. The writ petition stands disposed of in the above terms. All pending miscellaneous application(s), if any, to also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 19.06.2025 but the petitioner did not appear. However, another opportunity was granted to the petitioner on 03.07.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Lylh, Distt. Chamba to GSSS Makol or GSSS Jaisinghpur or GSSS Karanghat or GSSS Dagoh or GSSS Salehra, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS Lylh, Distt. Chamba since 21.04.2022 and has completed his normal tenure at his present place of posting. At present, vacancies are not available in the above mentioned school where petitioner has requested for transfer. One, Smt. Shalini, TGT(NM) has been working in GSSS Makol, Distt. Kangra since 27.08.2021 and has completed her normal tenure of three years at her present place of posting.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Lylh, Distt. Chamba to GSSS Makol, Distt. Kangra vice Smt. Shalini, TGT(NM) and vice versa with TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration.

## ORDER

Whereas, Smt. Ruchina Lalit, TGT(NM) previously working in GSSS Pangi, Distt. Kinnaur has filed CWPNo.10532/2025 titled as Smt. Ruchina Lalit Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be adjusted to one of the stations of her choice in Distt. Kinnaur. The case of the petitioner was listed before the Hon'ble High Court on 02.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

" Taking note of the submissions made by learned counsel for the petitioner, the fact that the petitioner has already completed the requisite tenure at her present place of posting, which falls under the hard & tribal area and the fact that under the impugned office order, she has again been transferred to another hard and tribal area, this writ petition is disposed of with direction to respondent No.2/ competent authority to consider and decide the aforesaid representation of the petitioner dated 11.06.2025 (Annexure P-3) for consideration of her case for transfer to a soft area of her choice in accordance with law and applicable transfer policy, within a period of ten days from today. Kinnaur against vacancy vide this Directorate letter of even number dated 4.6,2025 with the prior approval of the competent authority. As per information received in this office, the petitioner Smt. Ruchina Lalit, TGT(NM) has joined at the place of her posting in GHS Panvi, Distt. Kinnaur on 13.06.2025 and having short stay. Therefore, keeping in view of position stated above the representation made by the petitioner is not acceded to. The representation is disposed of accordingly.
