ORDER

Whereas, the petitioner namely Smt.Raj Bala, Lect(History) is working at GSSS Kiarian (Una), has filed CWP No. 8681/2025 titled as Raj Bala vs State of HP before the Hon'ble High Court seeking therein relief regarding her adjustment on account of ill health of her husband. This case was listed on 26.05.2025 when the Hon'ble Court has given following directions:-

Consequently, in view of the above, this Court without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the competent authority to consider and decide the pending representation dated 4.4.2025 (Annexure P-3), of the petitioner 15 days prior to the retirement of the employee working in Government Senior Secondary School Sohari, District Hamirpur, Himachal Pradesh and if possible, petitioner, who is certainly in difficulty on account of ill health of her husband, is adjusted in afore school. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order. Liberty is reserved to the petitioner to file appropriate proceedings in appropriate court of law, if she still remains aggrieved. Pending applications, if any, also stand disposed of.

And whereas, In compliance of Hon'ble High Court order dated 26.05.2025 the petitioner was called for personal hearing on 29.07.2025 but she has informed that she is unable to attend the said hearing due to critical condition of her husband and further requested to transfer her to GSSS Sohari or GSSS Biar or GSSS Barsar or GSSS Jaure Amb Distt. Hamirpur, being medical ground of her husband.

And whereas, while examined her representation it is found that GSSS Sohari (Hmr) has already been allotted to Sh.Rajinder Kumar Lect.(History) in view of CWP No. 8384/2025 and at present no other stations of her choice are lying vacant and incumbents of these stations cannot be displaced as it may lead another unwanted litigation. And it is also found that she is posted in soft area as well as there is medical facilities are also available in Distt. Una and she can avail the same. However, as per para 12.1 of "Comprehensive Guiding Principals-2013" the transfer of the Government employees, it is clearly mentioned that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/ transfer any employee anywhere in the state keeping in view of the administrative exigencies/ convenience.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected.

With these observations, representation stands disposed of.
