Whereas, Sunita Kumari, TGT (NM) presently working in GMS Sharanal u/c GSSS Thalout, Distt. Mandi has filed CWP. No. 12347/2025- titled as Sunita Kumari, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that she may be transferred from GMS Sharanal u/c GSSS Thalout, Distt. Mandi to one of the station at his choice in Distt. Kangra/Una. The case of the petitioner was listed before the Hon'ble High Court on 30.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Having regard to the nature of prayer and order proposed to be passed in the instant petition, this Court sees no necessity to call for the reply from the respondents, who are otherwise represented by Mr. B.C.Verma, learned Additional Advocate General. Mr. Verma, states that since petitioner has not completed normal tenure at present place of posting, she is not entitled to seek transfer especially to a station of her choice, rather it is the sole prerogative of the employer to post an employee at a particular station.

Though this Court does not see any reason to differ with the aforesaid submission made by Mr. B.C.Verma, learned Additional Advocate General, but having taken note of Clause 5.4 of Transfer Policy formulated by the Government of Himachal Pradesh, which certainly enables an employee to seek transfer on the ground of couple case, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation (Annexure P-1) filed by the petitioner expeditiously, preferably within a period of three weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass speaking order. Pending applications, if any, stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 23.08.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GMS Sharanal u/c GSSS Thalout, Distt. Mandi to GSSS Chahbag or GSSS Kaloha or GHS Punani u/c GSSS Saleti or GMS Naleti u/c GMSSS Pragpur or GHS Sehri Distt. Kangra/Una against longer stayee or against vacancy

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Sharanal u/c GSSS Thalout, Distt. Mandi since 12.10.2023 and the petitioner has not completed her normal tenure of three years at present place of posting as per provision contained in Comprehensive Guidelines Principles-2013. Keeping in view the position stated above, representation of the petitioner is not considered and hereby rejected.
