## ORDER

Whereas, Bhupender Singh, Lecturer (School-New) English presently posted at GSSS Tauni Devi, Distt. Hamirpur was filed CWP No. 10668/2025 before the Hon'ble Court that he has preferred a representation on 03.06.2025 to respondent No.2 seeking redressal of his grievences against the impugned transfer order 28.5.2025 and same has not been decided by the respondent and further submitted that he would be content, in case, respondents No.2/competent authority is directed to consider and decide his representation.

The case was finally disposed of by the Hon'ble High Court on 04.07.2025 with the following directions:-

"Having regard to the above submission, the instant writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner, in accordance with law and applicable policy, within a period of two weeks from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand dispoed of."

And whereas, upon passing of above directions, while examined his representation it is found that he has already joined at transferred station i.e. GSSS Tauni Devi (HMR) on 30.05.2025 as well as other incumbent named Smt, Ranjna Kumari has also joined at GBSSS Hamirpur (HMR), hence his transfer orders cannot be cancelled as it may lead another litigation. Moreover, petitioner has been transferred at the distance of 14 KM only. It is also found that he is serving in Distt. Hamirpur for last 23 years as per report received from the Principal, GSSS Tauni Devi (HMR) and as per "Comprehensive Guiding Principles-2013" for regulation the transfer of State Government employees it is clearly mentioned at Rule-12.1 that no government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected.

With these observations, representation stands disposed of.

## OFFICE ORDER

Whereas, Sh. Hem Raj Sharma, DPE/Lect.(SN) Phy. Education who is under orders of transfer from Rissa (MND) to GSSS Saigaloo (MND) vice Sh. Chandervir, DPE/Lect. Phy.Education by clubbing his previous stay within the radius of 30 Kms, with TTA/JT vide this office order dated 03.06 2025, with the prior approval of competent authority. But, Sh Hem Raj Shrama, DPE/Lect.(SN) Phy. Education has filed CWP No.9522/2025 before the Hon'ble High Court against this transfer orders. This case was listed before the Hon'ble High Court on 03.07.2025 when the case was disposed of with the following directions:-

"At this stage, learned counsel for the petitioner submitted that petitioner's father is seriously ill and is on the death bed, therefore, it will be difficult for the petitioner to join at the transferred station i.e. GSSS Siagloo, which is at a distance of 50 K.Ms from his native place. Learned counsel further submittd that the petitioner would be content in case he is permitted to make a representation to respondent No.2/ Competent Authority and the said authority is directed to decide the same within a time bound schedule. Learned Deputy Advocate General is not averse to this prayer. In view of above, without interfering with the impugned order in respect of transfer of respondent No.3 to GSSS Rissa, District Mandi, this writ petition is disposed of with liberty to the petitioner to make a representation within five days to respondent No.2/Competent Authority for his suitable adjustment, thereafter, the same shall be considered and decided by the competent in accordance with law and applicable transfer policy, within a period of one week. Till such time, petitioner shall not be compelled to join at the transferred station. The petitioner shall be at liberty to take leave of the kind due. It is made clear that in case petitioner does not represent within the aforesaid period, the protection granted to him under this order shall automatically stand vacated. It goes without saying that respondent No.3 shall be permitted to join at GSSS Rissa, District Mandi. H.P. forth with. The writ petition stands disposed of in the above terms, so also pending miscellaneous application(s), if any."

And whereas, upon passing of above directions, petitioner was called for personal hearing on 19.07.2025 and during the course of hearing he has submitted a fresh representation wherein he has requested that due to his adverse family circumstances, he is unable to join at transferred station i.e. GSSS Saigaloo (MND), therefore, he has requested to transfer/adjust him GSSS Chauki Chandrahan (Mandi), GSSS Gharwasra (MND) against vacancy as his father is seriously ill and mentally not fit.

And whereas, as per direction passed by the Hon'ble High Court as mentioned above, while examining his representation, it is also observed that petitioner is serving in soft area for last 17 years within the radius of 12 Kms moreover where he has been transferred is also soft area as well as his home district and the enrollement in GSSS Saigaloo (MND) is 39 and the enrollment of requested stations i.e. GSSS Chauki Chandrahan (MND) is Zero, and GSSS Gharwasra (MND) is only 03 in the said subject. However, as per "Comprehensive Guiding Principles- 2013" for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view the administrative exigencies/convenience.

Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected and his transfer orders dated 03.06.2025 shall stand.

With these observationns, representation stands disposed of.
