The noteworthy objectives of the Youth Parliament programme have been lauded by all quarters including parliamentarians, academicians, school administrators, etc. In the past, many requests have been received to involve more institutions under the programme of the Ministry. Therefore, to increase the coverage under the Youth Parliament Programme of this Ministry to hitherto untouched sections and corners of the country, the Ministry designed a web-portal for the National Youth Parliament Scheme (NYPS) in 2019. The web portal was launched on 26th November, 2019 in Central Hall, Parliament House, New Delhi by the Hon'ble President of India in the august presence of the Hon'ble Prime Minister, other Ministers and Members of both the Houses of Parliament.

At present, the registration for the 4th Edition on the NYPS portal is underway. • E-training modules, videos, photographs and scripts in connection with Youth Parliament are available on the portal for online self-learning of the participants.

· After successful registration, the educational institutions will be able to

conduct youth parliament sittings in their respective institutions.

• Each student taking part in the sitting will get a Digital 'Certificate of Participation' and the Teachers-in-charge and Head of Institution will get a 'Certificate of Appreciation' through the web portal.

Each institution is allowed to conduct multiple Youth Parliament sittings

through separate registrations for separate batches of students.

I would, therefore, like to request you to issue necessary directions to the concerned authority to involve a large number of educational institutions of your State/UT in participating in the web portal-based National Youth Parliament Scheme (NYPS) of this Ministry regularly.

In addition, the State Education Boards and other relevant organisations could be requested for considering inclusion of Youth Parliament Programme as an extra- curricular activity/project work in Educational Institutions.

It is further requested that a Nodal Department/Officer to provide the names of institutions and their respective email IDs within the State/UT may be provided which will enable us to send detailed email communications for facilitating their participation in the web portal-based National Youth Parliament Scheme.
