Whereas, Lokesh Kumar, TGT (NM) presently working in GHS Chet, u/c GSSS Cheuni, Distt. Mandi has filed CWP. No. 15856/2025- titled as Lokesh Kumar, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GHS Chet, u/c GSSS Cheuni, Distt. Mandi at one of the stations of his choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 08.10.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-


***"Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondents /Competent Authority to consider and decide the aforesaid representation of the petitioner in accordance with law and as per applicable notification/policy within a period of three weeks from today. The decision so taken be also communicated to the petitioner. Pending miscellaneous application(s), if any, also stand disposed of."***

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 14.11.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GHS Chet, u/c GSSS Cheuni, Distt. Mandi to GHS Peplagalu u/c GSSS Sainj or GMS Tandi u/c GSSS Kharsi or GSSS Kotmoras or GSSS Moviseri, Distt. Mandi against longer stayee or against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working at GHS Chet, u/c GSSS Cheuni, Distt. Mandi since 07.05.2022. GHS Chet, u/c GSSS Cheuni which falls under hard area and the petitioner has completed his normal tenure in hard area i.e. two winters and three summers.

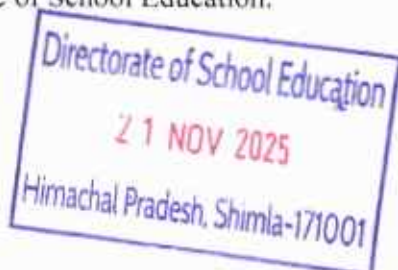

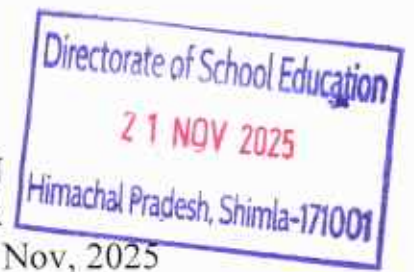
