ORDER

In the matter of:

CWP.No.18527 /2025- Sh. Virender Singh, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Virender Singh, TGT(NM) presently working in GHS Kotgarh, Distt. Shimla has filed CWP. No. 18527/2025 titled as Sh. Virender Singh Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GHS Kotgarh, Distt. Shimla to one of the stations of his choice in Distt. Bilaspur/Mandi. The case of the petitioner was listed before the Hon'ble High Court on 01.12.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Since bare perusal of aforesaid order passed in purported compliance of the judgment dated 25.09.2025 nowhere suggests that authority concerned considered the representation of the petitioner on the ground of couple case raised on behalf of the petitioner, this Court is persuaded to quash and set aside the afore order. Afore authority is directed to decide the case of the petitioner afresh strictly in terms of observations made hereinabove as well as in order dated 25.09.2025 passed by this Court in CWP No.15519 of 2025 expeditiously, preferably within three weeks from today. Ordered accordingly. Needless to say, authority concerned. while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders. Pending applications, if any, stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 01.12.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GHS Kotgarh, Distt. Shimla to GMS Kuthera Marahana u/c GSSS Bharari or GSSS Malyawar or GSSS Jukhala or GSSS Sikroha, Distt. Bilaspur or GSSS Chandesh, Distt. Mandi, against vacancy being couple case.

After perusal of relevant record, it is revealed that the petitioner has been working in GHS Kotgarh, Distt. Shimla since 17.09.2025. In the transfer policy at clause No. 5.4 it has been mentioned that in case wife and husband both are working under the State Government, efforts should be made to post them at one place or near places as far as possible, subject to vacancy. At present, one post of TGT(NM) is lying vacant at GSSS Sikroha, Distt. Bilaspur.

Therefore, keeping in view the clause mentioned in the transfer policy elaborated hereinabove in the above para, Sh. Virender Singh, TGT(NM) is hereby transferred from GHS Kotgarh, Distt. Shimla to GSSS Sikroha, Distt. Bilaspur, against vacancy without TTA/JT on his own request being couple case.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
