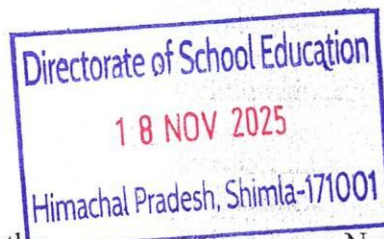
ORDER

The petitioner has filed present CWP in the Hon'ble High Court vide which sought her transfer at one of the station of her choice i.e. GMS Basal u/c GSSS Guggaghat Distt Solan. The present CWP was listed before the Hon'ble High Court of H.P. on 13.10.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 14-11-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Smt. Reena Devi, TGT (Arts), has submitted fresh representation and stated that she is working at GMS Dhar u/c GSSS Deothi Distt. Solan and is likely to be closed soon on account of decrease in strength of students so that requested for transfer/adjustment at GMS Bachhunch u/c GSSS Kui Distt. Shimla, GSSS Guggaghat, GMS Kandaghat(Girls) u/c GSSS Kandaghat Distt. Solan.

From the perusal of record, it is found that Smt. Reena Devi, TGT (Arts) is working at GMS Dhar u/c GSSS Deothi Distt. Solan since 10.01.2019 and has completed her normal tenure. Further the institution GMS Dhar, is situated in a soft area of District Solan, wherein 07 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right."

Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected on the grounds that the petitioner is presently posted at a soft area station and, in the larger interest of the students, her services are essentially required at GMS Dhar u/c GSSS Deothi Distt. Solan. It is further considered that the transfer of the petitioner at this stage would adversely affect the studies of the students during the mid-academic session. Hence, in view of the aforesaid facts and circumstances, the representation of the petitioner is rejected and stands disposed of. All the concerned are intimated accordingly.
