ORDER

Whereas, the petitioner namely Sh.Jagbir Chandel Lect.(Hindi) who is under order of transfer from GSSS Rangas (Hmr) to GSSS Guwan (Cba) against vacancy. Against this order he has filed CWP No. 20106/2025 before the Hon'ble High Court titled as Jagbir Chandel vs State of HP. This petition was listed on 19.12.2025 when the same was finally disposed with the directions to respondents as under:-

“The petition tabulates the incumbency position of the petitioner, in terms of which, it appears that petitioner has mostly served in District Hamirpur, even though he belongs to State Cadre. The petitioner, therefore, is liable to be transferred from his place of posting as he has completed his normal tenure even at this place. However, taking note of the fact that petitioner is left with about 17 months to superannuate and in terms of applicable transfer policy, an employee with less than five years to serve, is not ordinarily to be posted in hard area and considering the fact that under the impugned order, petitioner has been transferred to a hard area, it would be appropriate to dispose of this writ petition with liberty reserved to the petitioner to prefer a representation to respondent No.1/Competent Authority for his suitable adjustment within a period of one week with direction to respondent No.1/Competent Authority to consider and decide the aforesaid representation within a period of two weeks, thereafter. Copy of decision so taken, be communicated to the petitioner.

Till the decision of the representation, operation of office order dated 16.12.2025 (Annexure P-1) shall remain stayed qua the petitioner. It is made clear that in case petitioner does not represent within the aforesaid period, the interim protection granted to him under this order shall automatically stand vacated.

Pending miscellaneous application(s), if any, also stand disposed of.”

And whereas, in compliance of Hon'ble High Court order dated 19.12.2025, the petitioner was called for personal hearing on 16.01.2026 and he was present on this date. During the course of hearing petitioner has pleaded that he is on the verge of retirement i.e. 30.04.2027 and it is the violation of clause 5.5 of the transfer policy, 2013 and further requested that keeping in view of his retirement he may kindly be adjusted to one of the stations of his choice i.e. GSSS Rangas (Hmr), GSSS Bani (Hmr), GSSS Gander (Kgr), GSSS Lag Baliana (Kgr) against vacancy.

And whereas, after heard the petitioner as well as examined the representation of petitioner it has been observed that he is on the verge of retirement on 30.04.2027 and all the stations of his choice is lying vacant.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a representation of petitioner has been considered and allowed. The petitioner i.e Sh.Jagbir Chandel Lect.(Hindi) is being adjusted at GSSS Gander (Kgr) against vacancy as per his choice. Hence representation stands disposed of.

May inform the parties accordingly.
