ORDER

Whereas, Sh. Dhaugru Ram, DPE/Lect.(SN) Phy. Education has filed CWP No. 179/2026 before the Hon'ble High Court regarding seeking his transfer from GSSS Holi (CBA) (Tribal area) to his choice of station i.e. GSSS Bharmour (CBA) against longer stayee as he has completed his normal tenure at present place of posting.

The case was listed before the Hon'ble Court on 05.01.2026 when the case was disposed of with the following directions:-

“Since Transfer Policy, formulated by the Government of Himachal Pradesh, enables an employee working in hard/tribal area to seek transfer to another station, after his having completed normal tenure of posting, coupled with the fact that petitioner has been working in tribal area for more than five years and he is again seeking transfer in tribal area, this Court sees no impediment in issuing directions to respondents to consider and decide the pending representation of the petitioner, expeditiously.

Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation (Annexure P-1) of the petitioner, expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon. Pending application(s), if any, shall also stand disposed of”

And whereas, in compliance of Hon'ble High Court direction petitioner was called for personal hearing on 19.02.2026. During the course of hearing petitioner has requested that he is completed his normal tenure in tribal area and further requested that, his father is ill and above 75 years old, he require regular medical attention and personal care. Petitioner wife is also working as VT at GSSS Mandha (CBA). Being the only available member to look his father his presence at home has become essential. Keeping in view of his adverse family circumstance he may kindly be adjusted at GSSS Bharmour (CBA) against longer stayee by clubbing his previous stay with in the radius of 30 Km.

And whereas, while examined his representation it is found that at present Sh. Goverdhan Singh, DPE/Lect. Phy. Education is working at GSSS Bharmour (CBA) w.e.f. 11.07.2025 & having short stay, but prior to this he is serving within the radius of 30 kms and completing his stay by clubbing.

Now therefore, after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically and petitioner i.e. Sh. Dhaugru Ram, DPE/Lect.(SN) Phy. Education, who is posted at GSSS Holi (CBA) is hereby transferred to GSSS Bharmour (CBA), without TTA/JT vice Sh. Govardhan Singh, DPE/ Lect. Phy. Education and vice versa by clubbing his previous station stay within the radius of 30 Km with TTA/ JT.

With these observations, representation stands disposed of.
