ORDER

In the matter of:-

CWP No. 13365/2025-titled as Naresh Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court vide which sought his transfer from GMS Shawala u/c GSSS Mahasu district Shimla to one of the station of his choice (Soft area). The present CWP was listed before the Hon'ble High Court of H.P. on 20-08-2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"....Consequently, in view of the above, the present petition is disposed of, reserving liberty to the petitioner to file representation to the competent authority within a period of two days, detailing therein names of the stations, where he can be posted on account of adverse family circumstances, which in turn, shall be decided by the competent authority within a period of ten days, taking note of transfer policy formulated by the Government of Himachal Pradesh, which provides for transfer/adjustment of government employee on account of adverse family circumstances. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for personal hearing on 28.08.2025 and appeard before the undersigned on scheduled date. The petitioner has stated that he has completed normal tenure at present place of posting and parents of the petitioner have passed away, as result thereof, there is none to take care of his wife and two minor children, who at present are residing in Distt. Kangra therefore, sought/requested his transfer either to GMS Dhangar Tilla u/c GHS Dharhangar, GHS Mehwa, GHS Nandpur Bhatoli or GHS Katholi u/c GSSS Nagrota Surian Distt. Kangra.

From the perusal of record, it is found that Sh. Naresh Kumar, TGT (Arts) is working at GMS Shawala u/c GSSS Mahasu district Shimla since 23.11.2019 and has completed his normal tenure at present place of posting. At present post of TGT (Arts) is lying vacant at GHS Mehwa Distt. Kangra wherein 54 students are enrolled.

In view of above narrated circumstances, the representation of petitioner has been considered sympathically and the petitioner i.e. Sh. Naresh Kumar, TGT (Arts) is hereby transferred/adjusted from GMS Shawala u/c GSSS Mahasu district Shimla to GHS Mehwa Distt Kangra against vacancy (without TTA/JT). The representation of the petitioner in the present CWP stands disposed of. All the concerned be intimated accordingly.
