Kangra, H.P / againat longer stay by clubbing his/her previous stay radius of 30 Kms.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Railla, Distt. Chamba, H.P, since 14-11-2019, which is a sub cadre area and has completed the normal tenure of three years at present place of posting. The petitioner has given willingness for his transfer to the aforesaid school i.e GSSS Dainkwin, Distt. Kangra, H.P against vacancy being caused due to retirement of present incumbent on 31-12-2024. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and he is hereby transferred without TTA/JT from GSSS Railla, Distt. Chamba, H.P to GSSS Dainkwin, Distt. Kangra, H.P., against vacancy being caused due to retirement of present incumbent on 31-12-2024. These orders will be implemented after the retirement of present incumbent. The representation of the petitioner is disposed of accordingly.
