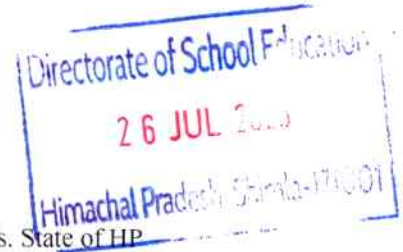

**ORDER**

In the matter of:-

CWP No.9435/2025-titled as Pradeep Kumar, TGT (Arts) V/s. State of HP  
CWP No.11090 of 2025 titled as Rekha Kumari Vs State of HP  
(Regarding transfers/adjustment)

Whereas petitioner Sh. Pradeep Kumar, TGT (Arts) in CWP No. 9435/2025 titled as Pradeep Kumar Vs State of H P was filed in the Hon'ble Hgh Court of HP and sought following prayer:-

A.) That the impugned transfer order dated 03.06.2025 (Annexure P-2) (petitioner transfer ordes from GSSS Galore, District Hamirpur, H.P. to Govt. Sr. Sec.School Ramnagar, District Shimla, H.P. vice Neeta Devi, TGT(Arts)) is arbitrary, illegal and unconstitutional, hence, the same is liable to be quashed and set aside.

B.) That the respondent No.3 has managed her transfer on political consideration and as consequences thereof, present petitioner was ordered to be transferred in place of respondent No.3 i.e. Govt. Sr. Sec. School Ramnagar, District Shimla, H.P. despite that fact that the petitioner has joined the present place of posting on 16.05.2025 and he has again been transferred within a short span of 17 days only.

The case was listed before the Hon'ble High Court of H.P. on 27.06.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

**"....Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Tansfer Policy. Till the time, representation, as detailed herein above , is not decided in terms of instant order, petitioner shall not be compelled to join at transferred station in terms of impugned transfer order. Interim order, if any, stands vacated."**

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 9435/2025 titled as Pradeep Kumar VS State of HP, the petitioner Sh. Pradeep Kumar, TGT (Arts) representation was decided and adjusted at GHS Patnaun Distt Hamirpur against vacancy, being caused due to the retirement of present incumbent on 31-07-2025, without TTA/JT. The petitioner will join after superannuation of present incumbent i.e. after 31-07-2025. The representation of the petitioner in the present CWP stands disposed of accordingly.

Whereas the Hon'ble High Court of HP has passed orders in CWP No. 11090/2025 titled as Rekha Kumari Vs State of HP dated 24.07.2025. The operative portion of the order is as under :-

**"It was on 15.07.2025 that the respondents were directed to place on record instructions regarding the feasibility of adjusting the petitioner at GMHS Patnaun, District Hamirpur, upon availability of a vacancy at the said place on 31.07.2025. 2. Learned Deputy Advocate General has placed on record a copy of the order dated 23.07.2025 passed by the Director, School Education and submits that another TGT has been adjusted at GHS Patnaun, District Hamirpur, against the aforesaid anticipated vacancy. 3. Under the office order dated 23.07.2025, one Sh. Pradeep Kumar (TGT) has been adjusted at Patnaun, even though there were no specific directions from the Court to adjust him at that particular place. The office order placed on record by the learned Deputy Advocate General was issued on 23.07.2025, whereas the order dated 15.07.2025, directing the respondents to specifically consider the feasibility of adjusting the petitioner at Patnaun, was passed earlier."**

Whereas, from the perusal of record, it is found that Smt. Rekha Kumari, petitioner has joined at GSSS Kinnu Distt Una on dated 21.05.2025 and having short stay.

Whereas, in compliance with the order of the Hon'ble High Court of Himachal Pradesh in Case No. 11090/2025 titled Rekha Kumari Vs State of HP, the adjustment order dated 23.07.2025 issued in CWP No. 9435/2025 titled Pradeep Kumar, TGT (Arts) Vs State of HP, whereby Shri Pradeep Kumar, TGT (Arts), who is under order of transfer from GSSS Galore, District Hamirpur to GSSS Ramnagar, District Shimla, has been adjusted at GHS Patnaun, District Hamirpur against the vacancy caused due to the retirement of the present incumbent on 31-07-2025, is hereby kept in abeyance until further orders from the Hon'ble High Court. All the concerned are intimated accordingly.
