
ORDER

The petitioner has filed present CWP No. 14561/2024 titled as Varinder Kumar V/s State of H.P. in the Hon'ble High Court vide which seeking his transfer from GHS Bakhhol, District Shimla to GMS Damoh u/c GSSSMinjgran, GSSS Minjgran, GSSS Banoli, GSSS Behi Pathiar, District Kangra. The case was listed before the Hon'ble High Court of H.P. on 06-01-2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"This Writ Petition is accordingly disposed of with the direction that the representation filed by the petitioner be decided by the Competent Authority in light of the averments made therein within a period of four weeks from today. Pending miscellaneous application(s), if any also stand disposed of accordingly"

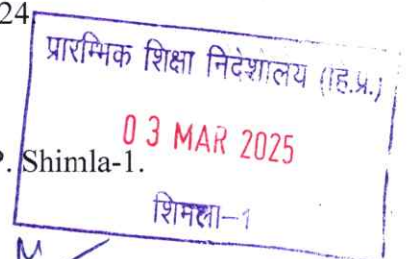
In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner Sh. Varinder Kumar, TGT (Arts) has attended the personal hearing on 22-02-2025 and has submitted representation, wherein request to transfer him from GHS Bakhhol, District Shimla to GMS Damoh u/c GSSSMinjgran, GSSS Minjgran, GSSS Banoli, GSSS Behi Pathiar, District Kangra.

From the perusal of record, it is found that Sh. Varinder Kumar, TGT (Arts) is working at GHS Bakhhol (soft area) District Shimla since 01-03-2021 wherein the enrollment of students is 23 (Aprx.). As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right." Therefore, being a State cadre Government employee, the request of the petitioner is not tenable and hereby rejected. The representation of the petitioner with the present CWP is disposed of accordingly.
