Whereas, Sh. Khushal Singh, TGT (NM) preferred CWP No. 12794/2024 titled as Khushal Singh, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Rulyani, U/C GSSS Dalhousie, Distt. Chamba, H.P to nearby home station in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 13-11-2024, when the Hon'ble High Court has passed the following orders:-

2. "Looking to the ailments statedly suffered by the petitioner, it is deemed appropriate to disposed of the present writ petition by directing the respondernts/ competent authority to consider and decide the aforesaid representation of the petitioner in accordance with law but symoathetically within a period of three weeks from today. The order so passed be also communicated to the petitioner."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 06-12-2024. He attended the same and submitted his representation in this office on 06-12-2024, vide which he has requested that he may be transferred from GMS Rulyani, U/C GSSS Dalhousie, Distt. Chamba, H.P to nearby native place in Distt. Kangra, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. on medical grounds.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Rulyani, U/C GSSS Dalhousie, Distt. Chamba, H.P, w.e.r 23-03-2023 and has not completed the normal tenure of three years at present place of posting. In October & November, 2023, the petitioner had to undergo brain surgery at GPIMER, Chandigarh and the petitioner is still under treatment for his heart and brain ailments. One Sh. Sanjay Kumar, TGT(NM) is working in GMS Malkwal, U/C GSSS Kukher, Distt. Kangra, H.P, since 18-12-2020. The petitioner has given willingness for his transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and he is hereby transferred on medical grounds without TTA/JT from GMS Rulyani, U/C GSSS Dalhousie, Distt. Chamba, H.P to GMS Malkwal, U/C GSSS Kukher, Distt. Kangra, H.P vice Sh. Sanjay Kumar, TGT(NM), against longer stay, with TTA/JT to Sh. Sanjay Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
