ORDER

Whereas, Smt. Renu Kumari, Lecturer (English) who was transferred from GSSS Bhararia (Shimla) to GSSS Rinjat (Shimla) vice Smt. Veena Khangta, Lecturer (School-New) English by clubbing her previous stay within the radius of 30 KM vide this office order dated 16.05.2025. But against these orders Smt. Renu Kumari, Lecturer (School-New) (English) has filed CWP No. 8324/2025 before the Hon'ble High Court as pleaded that she has been transferred without completing of her normal tenure at present place as well as her transfer has been made on basis of D.O note and the case was listed before the Hon'ble High Court on 18.06.2025 and in first instance Hon'ble Court stayed the said orders and the said case was listed before the Hon'ble High Court many times but no final outcome is come till date and next date of hearing is 29.7.2025.

And whereas, in view of to sattle the said case both the incumbents (petitioner & respondent No-3) were called for personal hearing on 02.06.2025. During the course of hearing, petitioner has requested she is unable to join at transferred station due to her adverse family circumstances as her husband is a Sr. Resident at Cadiac Anesthesia at IGMC Shimla and her only daughter is studing 5th calss and has been admitted in the school in the Shimla city and as such she needs utmost care and guidance at this tender age. There is no one except us (parents) to care for her and further requested that she may be permitted to resume her duties at her original place of posting i.e. GSSS Bhararia (SML) in pursuant to stay of transfer order by the Hon'ble High Court. But, Smt. Veena Khangta (respondent No-3) has also requested that she may kindly be allowed to retain at GSSS Bhararia (SML) until the final decision of Hon'ble High Court as well as she has joined her duties and started academics responsibilities and a sudden relieving would disrupt both the academic session and personal logistics.

And whereas, Later on Smt. Renu Kumari (petitioner) has requested that she will be withdraw her petition if she may be suitably adjusted in Shimla being her family circumstances. The request of the petitioner has been examined and found that at present there is no post of Lecturer (English) lying vacant in Shimla city where petitioner can be adjusted. However, post of Administrative Officer is lying vacant in the O/o Directorate of School Education and petitioner can be temporarily adjusted against this post.

Now therefore, after taking into account the above facts and circumstances of the case, a request of petitioner is considered sympathetically and petitioner Smt. Renu Kumari, Lecturer (School-New) (English) who is under order of transfer from GSSS Bhararia (SML) to GSSS Rinjat (SML) is temporarily being adjusted in the O/o Directorate of School Education, HP against the vacant post of Administrative Officer without TTA/JT and transfer orders of Smt. Veena Khangta issued on 16.5.2025 shall stand.

With these observations, representation stands disposed of.
