Whereas, Gulshan Nanda, TGT (NM) presently working in GHS Sarog u/c GSSS Dhulara District Chamba has filed CWP. No. 15652/2025- titled as Gulshan Nanda, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GHS Sarog u/c GSSS Dhulara, District Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 06.10.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Having regard to the above submissions, but without examining the merits of the matter, the instant writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner, in accordance with law, within a period of three weeks from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 30.10.2025 but petitioner did not appear. However, another opportunity was granted to the petitioner on 14.11.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GHS Sarog u/c GSSS Dhulara, Distt. Chamba to GSSS Zamanabad or GSSS Nandrool or GMS Lanjhani u/c GSSS Gharoh or GSSS Shahpur or GHS Ketlu, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner has been working at GHS Sarog u/c GSSS Dhulara, Distt. Chamba since 01.08.2022. Though the said teacher has completed his normal tenure of three years at GHS Sarog u/c GSSS Dhulara but at present, vacancies are not available in the above mentioned schools where petitioner requested for transfer. The cadre of the TGT (NM) is State Cadre and can be transferred/posted in the state as per transfer policy. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.
