Whereas, Sh. Ram Gulam Shiv Sagar, Headmaster, who is presently working in GHS Bhujund, U/C GSSS Tindi, Distt. L&S has filed CWP No. 10583/2025- titled as Ram Gulam Shiv Sagar, Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS GHS Bhujund, U/C GSSS Tindi, Distt. L&S (tribal area) to nearby his native place in Distt Mandi, H.P. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 03-07-2025, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

"5. Consequently, in view of the above, present petition is disposed of with direction to the respondents to consider and decide his pending representation, expeditiously, preferably, within three weeks. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of the transfer policy formulated by the Government of Himachal Pradesh. Pending applications, if any, also stand disposed of."

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 29-07-2025. The petitioner has attended personal hearing on 29.07.2025 and requested that he may kindly be transferred from GHS Bhujund, U/C GSSS Tindi, Distt. L&S, H.P.(Tribal Area) to soft area at GHS Kanjyan, GHS Barara, Distt. Hamirpur and GHS Banardhi, Distt. Mandi, against vacancy.

Of the perusal of the record, it is found that the petitioner is working in GHS Bhujund, U/C GSSS Tindi, Distt. Lahaul & Spiti, since July, 2023 which is a Tribal area and he has almost completed his normal tenure at his present place of posting. He has given three stations of his choice in District Hamirpur and Distt. Mandi, H.P. At present the post of Headmaster is lying vacant at GHS Banardhi, Distt. Mandi, H.P. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred from GHS Bhujund, U/C GSSS Tindi, Distt. Lahaul & Spiti, to GHS Banardhi, Distt. Mandi, H.P, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
