**OFFICE ORDER**

In the matter of: CWP No. 10899/2025-titled as Hari Lal, DPE, Vs. State of H.P &Others.

Whereas, Sh. Hari Lal, **DPE** Lect. Phy. Education preferred CWP No. 10899/2025 titled as Hari Lal Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Sechunala, Distt. Chamba to GSSS Nandrol, Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 08-07-2025 when the Hon'ble High Court has passed the following orders:-

7. "Consequently, in view of the above, this Court finds merit in the present petition and accordingly the same is allowed. Impugned order dated 04.06.2025 is quashed and set-aside, qua the petitioner only, reserving liberty to the respondents to transfer the petitioner from the present place of posting to a station of choice to the petitioner, which in any eventuality, shall be furnished by him within a period of two weeks to the competent authority. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order. In the aforesaid terms, present petition is disposed of along with pending application(s), if any "

In compliance to the dictions of Hon'ble High Court, the petitioner was called for personal hearing on 30-07-2025. The petitioner has attended personal hearing on 30-07-2025 and requested that he may kindly be transferred/ adjusted at GSSS Karyuni(Pangi), GSSS Sach (Pangi), Distt. Chamba, GSSS(Girls) Sultanpur, GSSS (B) Dhalpur, GSSS Mohal, Distt. Kullu, against vacancy/ against longer stay .

On the perusal of the record, it is found that the petitioner is working at GSSS Sechunala, Distt. Chamba and under transfer to GSSS Nandrol, Distt. Kangra, which is soft area and has completed his normal tenure at his previous place of posting. At present post of DPE/ Lect. Phy. Education are not lying vacant at the schools given by the petitioner. However, as per "Comprehensive Guiding Principles- 2013" for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected and petitioner is hereby directed to join at his transfer station i.e GSSS Nandrol, Distt. Kangra, H.P, with TTA/JT. The representation of the petitioner is disposed of accordingly.
