## ORDER

In the matter of:

CWP No. 16839/2025- Sh. Vikram Singh, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Vikram Singh, TGT(NM) presently working in GUSSS Tundi, Distt. Chamba has filed CWPNo.16839/2025 titled as Sh. Vikram Singh Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GUSSS Tundi, Distt. Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 29.10.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation of the petitioner expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of observations made hereinabove as well as averments contained in the petition that one Mr. Sumar Kumar, TGT (Non-Medical) posted at GSSS Kopra, District Kangra, has expressed his willingness to exchange posting with the petitioner. Pending application(s), if any, also stands disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 19.11.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GUSSS Tundi, Distt. Chamba to GSSS Behi Pathiar or GSSS Chalwara or GSSS Jounta, against vacancy or GSSS Kopra vice Sh. Suman Kumar, TGT(NM) on mutual basis.

After perusal of relevant record, it is revealed that the petitioner has been working in GUSSS Tundi, Distt. Chamba since 07.05.2025.One Sh. Suman Kumar, TGT(NM) has been working in GSSS Kopra, Distt. Kangra since 03.05.2021 and has completed his normal tenure of three years.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GUSSS Tundi, Distt. Chamba to GSSS Kopra, Distt. Kangra vice Sh. Suman Kumar, TGT(NM) and vice versa on mutual basis, without TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
