**ORDER**

Sh. Naseer Mohd., JBT has filed CWP No. 17987/2025, titles as Naseer Mohd, JBT Vs State of HP, before the Hon'ble High Court for his transfer. The case was listed before the Hon'ble High Court on 20.11.2025, when the same was disposed of with following order;

*“Since petitioner has already completed normal tenure of posting at the present place of posting i.e. two winters and three summers, there appears to be no impediment inasmuch as issuing directions to respondents to consider and decide the pending representations (Annexure P-2 & P-3) of the petitioner expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders. Pending application(s), if any, also stands disposed of.”*

In compliance of the above direction of the Hon'ble High Court, the petitioner was called for personal hearing on 24.01.2026 when the representation submitted by the petitioner has been examined in detail. On the perusal of comments submitted by the DDSE(Ele.) Chamba, it is revealed that the petitioner Sh. Naseer Mohd., JBT has been working at GPS Biyoti, E/B Bhamour, Distt. Chamba, situated in hard area, since 30.12.2023. The petitioner has requested for his transfer to one of the vacant stations of his choice i.e. (1) GPS Saunda (2) GPS Saproth, E/B Tissa & (3) GCPS Nera, E/B Kalhel, Distt. Chamba, HP.

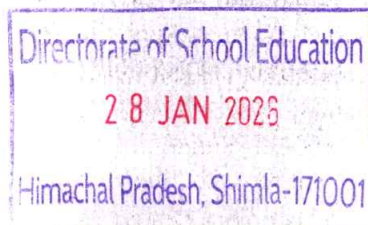
In view of above facts, representation of the petitioner has been examined after due consideration. Therefore, the Deputy Director of School (Ele.) Education, Chamba is hereby directed that the petitioner Sh. Naseer Mohd., JBT, may be transferred from GPS Biyoti, E/B Bhamour to GPS Nera, EB Kalhel, Distt. Chamba, H.P., on request, against the vacant post of JBT in the said school as present enrolment of GPS Nera, EB Kalhel is 54 and two posts of JBT are lying vacant. The DDSE(Ele.), Chamba is further directed to post a substitute at GPS Biyoti first, in place of Sh. Naseer Mohd. so that the school does not remain teacherless. Hence, the representation of the petitioner stands decided and disposed off accordingly.
